#### **Product information, including uses/applications and source(s) of imports:**

The subject product, a pale, acidic, thermoplastic, high-softening point resin, is a chemically modified natural product that is used as a tackifier/polymer modifier for adhesives used on such products as labels and tapes, coatings, inks, sealants, solder flux, and waxes. The subject product is imported from China.
