The subject products are organic herbicides that provide control of ryegrass, wild oats, other grasses, and broadleaf weeds to wheat growers. The products are imported from Germany.

- 3 SECTION 1. MESOSULFURONMETHYL.
- 4 (a) In General.—Heading 9902.11.48 of the Har-
- 5 monized Tariff Schedule of the United States is amended
- 6 by striking "12/31/2009" and inserting "12/31/2011".
- 7 (b) Effective Date.—The amendment made by
- 8 subsection (a) applies with respect to goods entered, or
- 9 withdrawn from warehouse for consumption, on or after
- 10 the 15th day after the date of the enactment of this Act.
