Proponent name, location: Various canned seafood distributors nationwide.³

Nature of bill: Extension of temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Oysters (other than smoked), prepared or preserved (provided for in subheading 1605.90.50).

Product information, including uses/applications and source(s) of imports:

The subheading covers oysters, prepared or preserved (except smoked oysters), thereby referring to those generally shipped in oil, vinegar, marinades, or other substances in airtight containers or in frozen, breaded form in any type of containers. According to the Explanatory Notes to the Harmonized System for this subheading, as issued by the World Customs Organization, these processed products may be boiled, steamed, grilled or otherwise cooked. Dutiable U.S. imports under this subheading in 2007 totaled 2.49 million kilograms, valued at \$8.6 million, compared with a 2004-06 annual average of 2.52 million kilograms, valued at \$8.5 million. The principal sources of U.S. imports of this product include Korea (accounting for about \$6.7 million), China (\$1.7 million), and Japan (\$213,000). U.S. production of canned oysters in 2006, as reported by the U.S. Department of Commerce, totaled just over 472,000 kilograms, valued at \$415,000 (about 5 percent of total supply).
