⁴ The Commission may express an opinion on the HTS classification of a product to facilitate consideration of the bill. However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

The Commission staff believes that this bill cannot be administered by Customs and Border Protection because the article description only contains a company product name. The bill needs to be rewritten to include a proper chemical name and a CAS registry number.
