(a) IN GENERAL.—Heading 9902.10.64 of the Harmonized Tariff Schedule of the United States (relating to
2,4–Dichloroaniline) is amended by striking the date in
the effective period column and inserting "12/31/2011".
(b) EFFECTIVE DATE.—The amendment made by
subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
