Aluminum tris (O-ethylphosphonate) (Fosetyl-Al) (CAS No. 39148–24–8) (provided for in subheading 2920.90.50).

Product information, including uses/applications and source(s) of imports:

The subject product is a synthetic organic chemical that is used as a fungicide to control *Alternaria*, *Oomycetes*, and *Peniciliium* on avocado, cacao, citrus, fruits, hops, ornamentals, pineapple, rubber, strawberries, tobacco, vegetables, and vines. The product also suppresses certain bacterial pathogens, *Erwinia* fire blight and *Pseudomonas* blister spot on pome fruit, and *Xanthomonas* on ornamentals. The product is imported from France.
