The fungicide is used to control certain plant diseases of potatoes and other tuberous and corm vegetables, tomatoes, onions and other bulb vegetables, lettuce (leaf and head), squash, melons, and cucumbers and other cucurbit crops. The subject product is imported from France.

- 6 Fenamidone) is amended by striking the date in the effec-
- 7 tive period column and inserting "12/31/2011".
- 8 (b) Effective Date.—The amendment made by
- 9 subsection (a) applies to goods entered, or withdrawn from
- 10 warehouse for consumption, on or after the 15th day after
- 11 the date of the enactment of this Act.
