Product information, including uses/applications and source(s) of imports:

The subject product is used to manufacture the active ingredient Prothioconazol, which is used to control leaf and head diseases on wheat and barley and to suppress mycotoxins. The product also controls a broad range of both foliar and soilborne diseases. The product is also used as a reducing agent and solvent, and as a component of propellants for rocket engines. The product is imported from France, China, and Germany.

RE: Arch Chemicals, Inc. Objection to H.R. 5458

Dear Mr. Chairman:

I am writing regarding H.R. 5458, which would suspend temporarily the duty on hydrazine monohydrate. Arch Chemicals, as the only U.S. producer of Hydrazine Hydrate, and Hydrazine Propellants. Production is located at our facility in Lake Charles, Louisiana. As such Arch objects to this proposed tariff change.

My understanding is that H.R. 5458 would allow imports ofhydrazine hydrate to enter the U.S. at a zero percent duty compared with the current 3.7% duty. This would allow imports of hydrazine hydrate to enter from countries which have a combination of lower production costs and higher import duties on hydrazine products produced in the U.S.

We object to H.R. 5458 as it would negatively affect our ability to competitively produce hydrazine hydrate in the U.S. and supply it to the domestic and international markets.

Most notably, in 2004 China imposed a duty of 184% on imports of U.S. produced hydrazine. The duty remains in effect today. This effectively takes away Arch Chemicals' ability to compete in the growing Chinese market. If the duty is abolished it will also allow the Japanese, Germans and French to import without duty while US exports will continue to pay duty of approximately 5% to these areas.

Additionally, Arch Chemicals has previously objected to a similar hydrazine tariff suspension request. In 2005, we objected and blocked an attempt to suspend the tariff on hydrazine hydrate (H.R. 2438 in the 109thCongress).

Headquartered in Norwalk, Connecticut, Arch Chemicals, Inc. is a global Biocides company with annual sales of approximately \$1.5 billion. Together with its subsidiaries, Arch has 1,200 U.S. employees and manufacturing facilities in North America, South America, Europe, Asia and Africa.
