SUBJECT: New Installation Management Requirements

1. The enclosed memorandum identifies a new requirement for installation commanders to begin adding elements of the International Organization for Standardization (ISO) 14001 Environmental Management System (EMS) to their existing management structure NLT FY04. In accordance with Executive Order 13148, "Greening the Government Through Leadership in Environmental Management," an EMS should be in place at appropriate installations by December 31, 2005. Full conformance with the ISO 14001 EMS Standard should be achieved NLT FY09.
2. Request you advise installation commanders to review this requirement and implement these changes within the identified time frames. Installations should request specific funding for this effort in their 04-09 POM requests, however commanders are encouraged to initiate changes as soon as possible within existing budgets.
3. The ISO 14001 EMS Standard is an internationally recognized best management practice. Implementation of this system will allow your environmental stewardship efforts to focus more on mission priorities and readiness issues while maintaining required compliance status.
4. My staff is currently preparing an implementation plan to assist Army installations in meeting this requirement. Further direction and guidance will be forthcoming. Information on DOD EMS activities can be found on the DENIX public menu site at <https://www.denix.osd.mil/EMS>.

SUBJECT: Army Environmental Management System – ACTION MEMORANDUM

Our goal is to actively promote mission readiness by continually upgrading environmental performance across Army installations. We want to improve the way environmental management supports the Army's mission. Therefore, I am directing that Army installations adopt the internationally recognized management system standard, ISO 14001, as a goal. Implementation of the standard will be incremental. It will be consistent with available funds and the requirements of Executive Order 13148, "Greening the Government Through Leadership in Environmental Management."

The importance of the Army's mission and Transformation demand a commitment to continual improvement in management practice. The purpose in adopting this standard is to use best-in-class business practices to enhance the Army's overall mission performance. This confirms Army's commitment to reducing risk and pollution, and to sustaining compliance.

Army installations already have strong environmental programs that include many elements of an environmental management system. Full use should be made of these existing capabilities. Installations may begin implementing ISO 14001 at any time. However, implementation shall be initiated NLT FY04, with an environmental management system in place NLT December 31, 2005. Full conformance with the ISO 14001 standard shall be completed NLT FY09. Third party registration to the standard is not required. However, installation commanders may pursue registration when it provides clear and documented mission benefits.

Request you advise the Major Commands of this new policy. Further request you prepare and brief me on an Implementation Plan within 60 days. Please prepare the plan in coordination with Mr. Michael Cain, (703) 614-9555 and Dr. Jean Shorett, (703) 602-0191.
