PNF Snowmobile Route Restrictions

Many snowmobile routes on the Plumas National Forest are closed to all wheeled motor vehicles including all-terrain vehicles (ATV's) effective December 15, 2008, through March 31, 2009, by forest order. Wheeled motor vehicles create ruts on maintained snowmobile trails which result in hazardous conditions for snowmobile operators. The forest has several major snowmobile areas: Four Trees, Bucks Lake, La Porte, and Lakes Basin.

Violations may cost \$5,000 for an individual, \$10,000 for an organization, or imprisonment for not more than six months or both in addition to the cost associated with restoring the trail.

Visitors are reminded that the Bucks Lake Wilderness Area is closed to all motor vehicles and bicycles. In previous years, snowmobile operators have been prosecuted for knowingly venturing into the wilderness area. With approximately 1.2 million acres and over 5,000 miles of roads and trails, Plumas National Forest has enough space for all types of outdoor recreational use.

When winter recreating in a vehicle, travelers should maintain a safe operating speed, wear helmets and warm clothing, and be aware of weather and current snow conditions. Travel plans should be shared with family or friends including an expected return time. If stranded, remain with the vehicle because it provides shelter, and it is easier to locate a vehicle in the forest than finding people on foot. While waiting for help to arrive, travelers can signal distress by using emergency flashers and by tying a handkerchief or flagging onto the antenna or mirror. The tailpipe should be kept clear and a downwind window open if the engine is run periodically for warmth.

Funding for Plumas NF snowmobile trail maintenance comes from the State of California Off Highway Vehicle Division.
