



GIS Processes

(Generic Interface System)

- Format Controller
- Output Controller
- HL IHS Lab Receiver
- HL IHS Lab Transmitter

Format Controller

 Based on defined interface routines, formats the outgoing messages into the HL7 format expected by the receiving application.

Output Controller

- "The Traffic Controller"
- Files outgoing formatted messages into the outbound queue and incoming formatted messages into the correct queue to be filed.


HL IHS Lab Receiver

- Used by both unidirectional and bidirectional interfaces.
- Associated with a pre-identified port and identifies the destination for incoming HL7 messages on that port.

HL IHS Lab Transmitter

- Used only by bidirectional interfaces.
- Identifies the address and port to which HL7 formatted reference lab messages will be sent.
