### 1. INTRODUCTION

This Program of Work (POW) document is a revision of the May 2006 Recreation Facilities Master Plan. As part of the regional forester's concurrence on the original POW, a commitment was made by the Forest to monitor progress and reach sustainable operations and maintenance levels within a year. This revision full fills that requirement. It will continue to be a living, working road map to guide the Forest in providing a quality, sustainable recreation sites program. It describes the vision for the overall Forest recreation program and outlines proposals specific to individual developed recreation sites.

The proposals and guidance contained in this document were developed through, and are the end result of, the national Recreation Facilities Analysis (RFA) process, formerly known as Recreation Site Facility Master Planning (RS-FMP). Existing and projected visitor demands, recreation program niche, resource conditions, links to the community, program costs, and revenue were all considered in developing recommendations.

This document will serve as a framework from which the Forest will prioritize investments, and pursue changes in operations or maintenance of recreation sites. Proposals are wholly consistent with the Intermountain Region's "Recreation Strategy", and the Caribou-Targhee Forest Land and Resource Management Plan.

The Forest recognizes that site-specific analysis and public involvement may be necessary prior to implementing some of the proposals contained in this document. As implementation of site-specific proposals are considered, they will be evaluated to determine if they are subject to the National Environmental Policy Act (NEPA) and all required procedures shall be executed.

The Forest also recognizes that proposals relating to fees will require consistency with criteria outlined in the Recreation Enhancement Act (REA) and coordination with the appropriate Recreation Resource Advisory Committee (RRAC).

## 2. SUMMARY - Programmatic Effects Of Implementation

## A. BRIEF DESCRIPTION OF PROCESS

The purpose of Recreation Sites Facility Master Planning is to display the proposed tasks needed over the next 5 years to bring the Forest's recreation infrastructure into alignment with the resources available to operate and maintain it to standard. Many of our facilities were built 30-50 years ago and have reached the end of their useful life without significant deferred maintenance investment. Other facilities receive no or little use, and no longer serve the demand that existed 30-50 years ago. The fundamental premise of the proposed program of work is to create an inventory which is sustainable and flexible enough to be annually adapted to any changes in available resources. The proposed program of work is designed to meet the following objectives:

- Operate and maintain sites to standard within available revenue stream.
- Reduce deferred maintenance by 20% over the 5 year life of the program of work.
- Focus available resources on sites which conform most closely to the Forest Recreation Program Niche.
- Maintain and enhance customer satisfaction with available sites.

The RS-FMP process defines the proposed actions for management of forest recreation sites in order to meet the desired future condition that aligns with the Forest Plan. For purposes of the analysis and planning for future proposed actions, four categories (A-D) of proposed management are used. These categories are:

- 1) <u>Category A:</u> sites that are under some type of operational or contractual agreement whose terms are longer than the 5-year period of the RS-FMP.
- 2) <u>Category B:</u> sites that meet the unit niche; are environmentally sustainable within the capability and capacity of the natural resources; are supported by and provide support to local communities; and have a sustainable management cost-benefit ratio.
- 3) <u>Category C:</u> sites that do not meet all of the above criteria, but with a combination of mitigation, additional resources, or other type of action could be made to qualify for Category B status.
- 4) <u>Category D:</u> sites that do not meet all of the (Category B) criteria; or fall sufficiently short in one or more of the criterion so as to render the capability of meeting it unsustainable. These sites may be managed for dispersed recreation opportunities.

Sites were evaluated and ranked based on conformance to the forest niche and amount of recreation use (35%), financial efficiency (35%), and environmental and community sustainability (30%).

Some sites were identified as non-discretionary based primarily on existing agreements such as concession permits.

# B. FOREST RECREATION NICHE

December 9, 2005 (For the coming decade)

### **ACCESSIBLE ADVENTURES**

The spectacular scenery of the Caribou-Targhee is easily reached from highways, byways, and back doors. The bond between forest and community spans generations through family activities such as camping, hiking, hunting, fishing, and riding OHV's. During the winter, the forest offers vast expanses of untracked powder; ideal for snowmobiling and skiing.

## Settings, Special Places, and Values

With its northern boundary on the Continental Divide, the C-T National Forest occupies over 3 million acres, stretching across southeast Idaho, western Wyoming and northern Utah. Bordering Grand-Teton and Yellowstone National Parks, the Forest serves as a gateway to the Greater Yellowstone Area. From high mountain peaks to rolling hills of sage; the diverse landscapes of the forest include the headwaters to the Henry's Fork and the South Fork of the Snake River. This diversity provides habitat for grizzly bears, wolves, elk, deer, and antelope. Key destinations include: Mesa Falls, Minnetonka Cave, Palisades Reservoir, the Curlew National Grasslands, Teton Canyon, Grand Targhee Resort, the Continental Divide Trail, Big Springs National Natural Landmark and the Charcoal Kilns. Forest history is rich with evidence of Shoshone and Bannock cultures, emigrant trails, and the remains of mining settlements from the 1880s.

<u>Quiet/remote</u> – These settings are remote and primarily non-motorized, they include Wilderness and non-wilderness areas. Valued as an escape from crowds and daily stress, these settings serve as quiet refuge to rejuvenate.

<u>Motorized/dispersed</u> – These settings are valued for their easy access and variety of motorized trail experiences. Camaraderie and a sense of freedom can be found here.

<u>Structured</u> – These areas are valued for their facilities, security, and predictability. They offer a safe and controlled interface with the Forest's natural and cultural resources. Forest uses are generally more restricted. <u>Backdoor</u> – These settings abut private lands and local communities. They are the "easy on/easy off" portions of the Forest and contribute to the daily quality of life for many local residents.

# **Activities/Opportunities/Experiences**

Winter activities include legendary snowmobiling and a wide range of Alpine and cross-country skiing experiences. Unique wildlife viewing, world-class big-game hunting, bird hunting, and blue ribbon fisheries await the user. Families come together to camp and reunite. Organization camps and summer homes are found throughout the Forest and function as an extension of the communities.

<u>Quiet/remote</u> – Hiking, backpacking, horseback riding, and cross-country and back-country skiing are the primary trail based activities. Dispersed camping and opportunities for environmental study, solitude and personal reflection are provided in these areas.

<u>Motorized/dispersed</u> – OHV trail can be the primary activity or the means of travel for a variety of dispersed activities. Camping, visiting natural features, and gathering forest products are common activities within these settings.

<u>Structured</u> – Developed camping, snowriding at developed resorts, driving for pleasure, viewing scenery, interpretive opportunities, and water-based activities occur here.

<u>Backdoor</u> – Short duration, day-use activities occur such as: jogging, mountain biking, hiking, walking the dog, and OHV riding are common activities within these settings.

### **Operations and Maintenance:**

To summarize the above revenue and expenses, the predicted annual revenue (including predicted allocation for O&M of developed recreation sites, fee receipts and other funding) totals: \$591,514. The predicted annual O&M costs are \$492,332. This equates to an anticipated annual surplus of \$99,182. This surplus will be available upon completion of the "Table of Tasks", beginning on page 13 of this document.

# **Deferred Maintenance:**

Implementation of proposed actions will also result in a 51% reduction in deferred maintenance. Although the majority of this reduction reflects corrections made to the infra data base, some of the reduction will result as proposed decommissioning and other actions outlined in this Program of Work are implemented.



Annual O&M Cost per visit and per PAOT day are averages derived from a summation of ALL the 126 analyzed recreation facilities on the Forest; the cost per visit and per PAOT for each site and site type will vary.

- PAOT An acronym for Persons-At-One-Time; a measure of facility or site <u>designed</u> recreation carrying capacity, particularly for developed sites. National conventions include 5 persons per family picnic/camp unit, 3.5 persons per parking lot stall at a trailhead or visitor center, 1.5 persons per motorcycle parking stall and 40 persons per tour bus parking stall.
- O&M Operations and maintenance; includes the activities and resources required to annually operate and maintain recreation sites at a level of quality which meets their management objectives and customer satisfaction. Costs associated with O&M are generally recurrent, as opposed to capital investment costs that are generally one-time and non-recurrent.

### 5. MONITORING

**Questions** the Forest would like to answer tie directly back to the primary objectives of RFMP: Increasing visitor satisfaction, supporting communities, being financially sustainable and environmental protection. Specific questions include:

- Are recreation sites and opportunities more consistent with demand, niche, use levels, and user expectations?
- Are recreation sites meeting quality standards?
- Are annual operation and maintenance costs within the Forest's available revenue stream?
- Is deferred maintenance being reduced at projected rates?
- Are environmental conditions affected by recreation use improving?

## Monitoring methods will include:

 Annually review RS-FMP Program of Work to determine if any triggers for change require a change in course. Trigger.

**Potential triggers for a change.** Some of the original assumptions and projections from which actions were developed may change. In some cases, the changes may warrant a change in either the objective(s) being pursued or the actions by which the objectives can be achieved. Examples of some triggers that may warrant a re-evaluation of the Program of Work include:

Decreases in budgets (i.e. WCF implications, shifts in budget priorities, etc.)

Changes in standards (i.e. EPA water system standards)

Changes in local, regional, or national conditions (i.e. the price of gas, fires, etc.)

Increased use levels

Increased use conflicts

Changes in technology that alter use patterns or time frames.

- Determine and document percentage of actions actually completed during fiscal year in relation to those planned to be completed during fiscal year.
- Annually review the RS-FMP Five-Year Action Plan. Determine and document percentage of actions
  actually completed during fiscal year in relation to those planned to be completed during fiscal year.
  Acceptable performance is 90%.
- Annually review deferred maintenance values to assure that adequate progress is being made to reduce deferred maintenance by 20% within 5 years of approval of this Action Plan. In order to comply with existing direction and to allow deferred maintenance values to be monitored, the Caribou-Targhee National Forest annually will conduct, document, and enter into Infra, facility condition assessment surveys for 20% of the recreation sites, including linked constructed features.
- Review results of Region's Recreation Site Monitoring ("Secret Shopper") program. Acceptable
  performance is an average score of 4.0 or better when compared to meeting Regional required quality
  standards.
- Review National Visitor Use Monitoring data, provided at five-year intervals, to assure that customer satisfaction levels relevant to the Forest's developed recreation site program are maintained or increased.
