Dear Ambassador Schwab:

I have the honor to confirm the following understandings reached between the Governments of Panama and the United States:

- 1. Panama shall take the following actions with respect to tariff-rate quotas provided for in Section I-B of Schedule CXLI Panama to the General Agreement on Tariffs and Trade 1994 (GATT 1994), in conformity with Article XXVIII of GATT 1994:
 - (a) no later than the date of entry into force of the Panama - United States Trade Promotion Agreement (Agreement), reduce to zero the bound rate of duty on the in-quota quantities of goods imported before March 1 or on or after September 1 of each calendar year under the tariff-rate quotas that Panama maintains on goods classified under tariff items 20029011, 20029012, and 20029019; and
 - (b) no earlier than the date of entry into force of the Agreement, withdraw the tariff-rate quota that Panama currently maintains on goods classified under tariff items 10059090, 11042320, and 11042390.

"I have the honor to confirm the following understandings reached between the Governments of Panama and the United States:
