- ➤ **Business Transformation** Demonstration of how the solution was applied to fundamentally change the organizations business processes and its ability to deliver its mission. Have at least an operable prototype system by January 31, 2005.
- Available and Transferable Must be available and accessible regardless of economic or disability status. Must be replicable/transportable to other organizations and have widespread national or regional application.
- ➤ Impact and Results Demonstrates significant positive impact to the organization and/or its stakeholder community. Demonstrates sustainable outcomes which result in significant cost or time savings. Describe the improved performance and/or measurable results experienced after the solution was implemented.
- Technology Leadership Demonstrates a solution approach that serves as a model for other agencies or departments.

"Many organizations at all levels of government are using technology to streamline their processes for real service benefits, and the Intergovernmental Solutions Awards allow ACT to recognize those distinguished projects," said Barry C. West, President of ACT. "The Management of Change Conference brings participants together to identify strategies for leveraging technology and these programs have done that with phenomenal results."
