AMENDMENT OF THE EXPLANATORY NOTES ARISING FROM THE CLASSIFICATION  
OF GALVANIZED STEEL ROOFING TILES IN SUBHEADING 7308.90

I. BACKGROUND

1. At its 24<sup>th</sup> Session (October 1999), the Harmonized System Committee examined the classification of steel tiles used for constructional purposes.
2. It decided unanimously that these tiles were classifiable in heading 73.08 (subheading 7308.90) by application of General Interpretative Rules 1 and 6. It then decided that the Explanatory Note to heading 73.26 should be amended to take account of that classification.
3. To reflect this decision, the Secretariat was instructed to prepare a draft amendment to the Explanatory Note to heading 73.26 for examination by the pre-session Working Party.

II. SECRETARIAT COMMENTS

4. Acting on the Committee's instructions, the Secretariat has prepared and appended the requested draft amendment to the Explanatory Notes.

III. CONCLUSION

5. The Committee is invited to approve the appended proposed amendment to the Explanatory Notes once it has been finalized by the pre-session Working Party.
