ESTABLISHMENT OF A CORRELATION BETWEEN THE HARMONIZED SYSTEM  
AND VARIOUS INTERNATIONAL CONVENTIONS

I. BACKGROUND

1. At its 21<sup>st</sup> Session, the Harmonized System Committee examined a proposal by the US Administration aimed at establishing a correlation between the HS and various international conventions.
2. Following discussion, the Committee decided in favour of the publication, by the Secretariat, of an unofficial file establishing such a correlation. Several ideas were proposed regarding the presentation, method of circulation and content of this file, and the Committee instructed the Secretariat to continue its study and present a more detailed draft for examination at its next session.
3. At its 22<sup>nd</sup> Session, the Committee continued its examination of this proposal. The Committee drew up certain guidelines regarding the status, presentation, publication and content of the correlation table and noted that the Secretariat would continue its work with a view to finalizing the draft. The relevant part of the principles with regard to the guidelines drawn up at the 22<sup>nd</sup> Session of the HS Committee is set out in paragraphs 6 to 11 below.

## II. PRINCIPLES DRAWN UP BY THE COMMITTEE AT ITS 22<sup>nd</sup> SESSION

### Status

4. The correlation will be unofficial and be compiled by the WCO Secretariat in conjunction with the Secretariats of the organizations administering the conventions or agreements concerned.

### Presentation

5. The correlation table will comprise solely the HS codes covered by one (or more) convention(s), opposite which symbols will be indicated when one (or more) goods of the subheading are controlled by the convention mentioned in the header of the corresponding column. The symbol will differ according to whether all the products covered by the code or only some of them are covered by the relevant convention. The table will be preceded by a preamble specifying its status, scope and objectives and providing practical information on its use.

### Content

6. The correlation will include all the instruments mentioned in Annex I to Doc. NC0010E1, provided that the organizations administering them agree. Furthermore, although it would be preferable to have the various lists fully reflect the goods, it may be necessary for the correlation to be limited to the most frequently traded controlled products in certain cases (especially in the case of CITES). Accordingly, a flexible procedure (case by case) will be applied.
7. The correlation should also contain (1) information concerning the organization administering the instrument concerned (contact details, direct link with the organization's Internet sites, etc.), enabling users to access the convention texts and the lists of products controlled and (2) general information concerning each Convention, to be inserted at the request of the organization responsible for administering the Convention.

### Publication

8. The correlation will not only be made available on the WCO's Web site, enabling it to be consulted and if necessary downloaded by users, but will also be published on paper as an Annex to the Explanatory Notes, like the existing Annex establishing an interconnection between the HS and CITES.

### III. SECRETARIAT COMMENTS

9. As regards hazardous wastes controlled by the Basel Convention, the UNEP recently contacted the WCO Secretariat in order to explain the current situation with respect to the progress regarding the preparation of the correlation tables between the HS and the various lists of wastes. At the time of preparing this document, the Secretariat however had not received specific information from the UNEP. The Secretariat has, therefore, prepared the draft correlation table based on the Secretariat's own study and past discussions with the UNEP and OECD Secretariats. The Secretariat would note that the correlation could be re-examined based on new information to be provided by the UNEP and therefore all symbols in the columns have been placed in square brackets.
10. With regard to ozone depleting substances, the Secretariat has prepared the correlation based on the relevant part of the HS as well as the Recommendation adopted by the Council with regard to ozone depleting substances.
11. Concerning the CITES, the Secretariat has examined the existing Annex establishing a correlation between the HS and CITES (see Annex I to the Explanatory Notes) in conjunction with the CITES Secretariat, taking into account the HS 2002 amendments. Symbols in the column which appear to have been influenced by the HS 2002 amendments are underlined for the purposes of the Committee's examination.
12. Concerning narcotics, the relevant part of the HS and the Explanatory Notes to Chapter 29 (list of narcotics and psychotropic substances (Lists I to III)) have been referenced taking account of the HS 2002 amendments.
13. As regards the Chemical Weapons Convention, the Secretariat has prepared the correlation on the basis of the Recommendation concerned adopted by the Council.
14. Taking into account paragraphs 9 to 13 above and in view of the principles drawn up by the Committee as mentioned in paragraph 4 to 8 above, the Secretariat considers it most appropriate that the correlation should have the following structure and therefore would propose the publication as set out in the Annex to this document :
- I. INTRODUCTION
  - II. LIST OF CONVENTIONS AND THEIR ORGANIZATIONS
  - III CONTACT DETAILS RE THE ORGANIZATIONS ADMINISTERING THE CONVENTIONS
  - IV TABLE (Correlation between the product coverage of selected international conventions and the HS).
15. At the request of certain delegates in the past, it was envisaged that the publication should also include a correlation between the HS and various WTO instruments (civil aircraft, pharmaceutical products and ITA). The WTO Observer had indicated that her organization would not, in principle, be opposed to such a correlation, subject to certain conditions, though she noted that the WTO was still examining the question and might conceivably conclude that the correlation would be of little use (see Annex C/3 to Doc. 42.750, paragraph 4). No

additional information has been provided on this issue by the WTO. In this connection, the Secretariat would note that the Agreement on Civil Aircraft had been accepted in December 1986 and that the Annex had not been amended since then and was consequently not up to date. The Secretariat therefore considers it premature for the correlation table to contain references to the WTO agreements.

16. With regard to the publication of the correlation in hard copy, although it was agreed that it would be published as an Annex to the Explanatory Notes (see paragraph 8 above), the Secretariat proposes that it should be published as an Annex to the Classification Handbook.

#### IV. CONCLUSION

17. The Committee is invited to examine the draft correlation between the product coverage of selected international conventions and the HS, set out in the Annex to this document, taking into account the Secretariat comments above.
18. The Committee is also invited to express its view with regard to the publication of the correlation, taking into account the Secretariat comments as set out in paragraph 16.

## CORRELATION BETWEEN THE PRODUCT COVERAGE OF SELECTED INTERNATIONAL CONVENTIONS AND THE HARMONIZED SYSTEM

### I. INTRODUCTION

This publication contains the correlations between the Harmonized System and selected international conventions as drawn by the World Customs Organization Secretariat in collaboration with the Secretariats of the organizations administering the conventions or agreements set out below, in accordance with instructions received from the Harmonized System Committee.

Although the attached table was examined by the Harmonized System Committee, it is not to be regarded as reflecting classification decisions taken by that Committee; it constitutes a reference published by the WCO Secretariat for the purpose of facilitating the monitoring and control of certain products covered by other international conventions. The table is non-exhaustive and merely indicative and has **no legal or official status**.
