UNANIMOUS CONSENT AGREEMENT

S. 1082 (ORDER NO. 120)

Ordered, That at 9:30 a.m. on Thursday, May 3, 2007, the Senate resume consideration of S. 1082, a bill to amend the Federal Food, Drug, and Cosmetic Act to reauthorize and amend the prescription drug user fee provisions, and for other purposes; provided that there be an hour for debate prior to a vote on the motion to invoke cloture on Amdt. No. 990, with the time equally divided between the Senator from North Dakota (Mr. Dorgan) and the Republican Leader or their designees; further, that upon the use or yielding back of time, the Senate proceed to a vote on the motion to invoke cloture on Amdt. No. 990.

Ordered further, That second degree amendments be filed by 10:00 a.m. on Thursday, May 3, 2007.

Ordered further, That relative to the cloture motion filed on Amdt. No. 990, the mandatory quorum required under Rule XXII be waived. (*May 1, 2, 2007.*)
