UNANIMOUS CONSENT AGREEMENTS

S. 294 (ORDER NO. 158)

1.—*Ordered*, That on Tuesday, October 30, 2007, upon the conclusion of Morning Business, the Senate resume consideration of S. 294, a bill to reauthorize Amtrak, and for other purposes; provided, that all first degree amendments be filed by 3:30 p.m. on Monday, October 29, 2007; further, that all second degree amendments be filed by 12 noon on Tuesday, October 30, 2007.

Ordered further, That on Tuesday, October 30, 2007, at a time determined by the Majority Leader, in consultation with the Republican Leader, the Senate proceed to a vote on the motion to invoke cloture on the bill, and that the mandatory quorum required under Rule XXII be waived. (*Oct. 26, 29, 2007.*)

H.R. 3963 (CALENDAR NO. 450)

2.—*Ordered*, That with respect to the cloture motion filed on the motion to proceed to H.R. 3963, to amend title XXI of the Social Security Act to extend and improve the Children's Health Insurance Program, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Oct. 26, 2007.*)
