**PENDING BUSINESS**

S. 1955 (ORDER NO. 417)

A bill to amend title I of the Employee Retirement Security Act of 1974 and the Public Health Service Act to expand health care access and reduce costs through the creation of small business health plans and through modernization of the health insurance marketplace. (*May 10, 2006.*)

**UNANIMOUS CONSENT AGREEMENTS**

H.R. 810 (ORDER NO. 119), S. 3504, S. 2754

1.—*Ordered*, That on Tuesday, July 18, 2006, at 10:00 a.m., the Senate resume consideration en bloc of the following bills: H.R. 810, an act to amend the Public Health Service Act to provide for human embryonic stem cell research; S. 3504, a bill to amend the Public Health Service Act to prohibit the solicitation or acceptance of tissue from fetuses gestated for research purposes, and for other purposes, which shall be discharged from the Committee on Health, Education, Labor, and Pensions; and S. 2754, a bill to derive human pluripotent stem cell lines using techniques that do not knowingly harm embryos, which shall be discharged from the Committee on Health, Education, Labor, and Pensions.

*Ordered further*, That no amendments be in order to any of the measures and that following the use or yielding back of time, the bills be read a third time and the Senate proceed to three consecutive votes in the following order: S. 3504, S. 2754, and H.R. 810, without intervening action or debate.

*Ordered further*, That the time be divided as follows:

10:00–10:30, Majority  
 10:30–11:00, Minority  
 11:00–11:30, Majority  
 11:30–12:00, Minority  
 12:00–12:15, Majority  
 12:15–12:30, Minority  
 2:15–2:45, Majority  
 2:45–3:15, Minority  
 3:15–3:30, Minority Leader  
 3:30–3:45, Majority Leader

*Ordered further*, That at 3:45 p.m., the Senate proceed to three consecutive votes.

*Ordered further*, That if any of these bills does not receive 60 votes in the affirmative, the vote on passage be vitiated and that bill be returned to its previous status on the Calendar or in the Committee on Health, Education, Labor, and Pensions; further, other than as provided in this agreement, it not be in order for the Senate to consider any bill or amendment relating to stem cell research during the remainder of the 109th Congress. (*June 29 and July 13, 17, 2006.*)

S. 728 (ORDER NO. 93)

2.—*Ordered*, That on Tuesday, July 18, 2006, at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to the immediate consideration of S. 728, a bill to provide for the consideration and development of water and related resources, to authorize the Secretary of the Army to construct various projects for improvements to rivers and harbors of the United States, and for other purposes; provided that the committee-reported amendments be withdrawn and the Managers' substitute amendment at the desk be agreed to as original text for the purposes of further amendment and that the only other amendments be in order be the following, the text of which are at the desk, with the specified time agreements equally divided in the usual form:

Boxer—Folsom Dam (1 hour)  
 Feingold/McCain—Mitigation Standards (1 hour)  
 Feingold/McCain—Peer Review (4 hours)  
 Inhofe/Bond—Independent Reviews (1 hour)  
 Inhofe—Fiscal Transparency (1 hour)  
 McCain/Feingold—Prioritization Report (2 hours)  
 McCain/Feingold—Chief of Engineers (1 hour)  
 Nelson (FL)—Water Projects (1 hour)  
 Specter—Federal Hopper Dredges (1 hour)

*Ordered further*, That there be 2 hours for general debate on the bill, and that following the disposition of amendments and the use or yielding back of time, the bill as amended

be read a third time and the Senate proceed to the consideration of Calendar No. 166, H.R. 2864, the House companion and that all after the enacting clause be stricken and the text of S. 728, as amended, be inserted in lieu thereof, that the bill as amended be read a third time and the Senate proceed to a vote on passage, and S. 728 be returned to the Senate Calendar; provided further, that no points of order be waived by virtue of this agreement. (July 14, 2006.)

S. 2611 (ORDER NO. 414)

3.—*Ordered*, That when the Senate agrees to a request for a conference or the Senate requests a conference on S. 2611 or a House bill, as amended with the language of S. 2611, as amended, the Chair be authorized to appoint conferees on the part of the Senate with the ratio of conferees being 14 to 12; provided further, that from that ratio, the first 7 Republican Senators from the Committee on the Judiciary and the first 5 Democratic Senators from the Committee on the Judiciary be conferees; further, that the Majority Leader select the final 7 conferees for the Majority side and the Democratic Leader select the final 7 conferees for the Minority side. (*May 11, 2006.*)

H.R. 22

4.—*Ordered*, That with respect to H.R. 22, an act to reform the postal laws of the United States, provided it shall not be in order for the Senate to consider any conference report or any House amendments to H.R. 22, if it would cause a net increase in on or off budget direct spending in excess of \$5 billion in any of the four 10-year periods beginning in 2016–2055, as estimated by the Congressional Budget Office. (*Feb. 9, 2006.*)

S. 295

5.—*Ordered*, That the Majority Leader, after consultation with the Democratic Leader, shall no later than September 29, 2006, or the last day of the second session of the 109th Congress, whichever is earliest, call up S. 295, a bill to authorize appropriate action if the negotiations with the People’s Republic of China regarding China’s undervalued currency are not successful; provided that if the bill has not been reported by then by the Committee on Finance it be discharged at that time and the Senate proceed to the consideration thereof; that there be 2 hours for debate equally divided between the Senator from Iowa (Mr. Grassley) and the Democratic Leader, or his designee, that no amendments or motions be in order, including committee amendments, that after the use or yielding back of time, the bill be read a third time and the Senate proceed to a vote on passage of the bill, with no intervening action or debate. (*July 1, 2005, Mar. 29, 2006.*)

S. 2766, S. 2767, S. 2768, S. 2769

6.—*Ordered*, That with respect to S. 2766, S. 2767, S. 2768, S. 2769, as passed, if the Senate receives a message with respect to any of these bills from the House of Representatives, the Senate disagree with the House on its amendment or amendments to the Senate-passed bill and agree to or request a conference, as appropriate, with the House on disagreeing votes of the two houses; that the Chair be authorized to appoint conferees; and that the foregoing occur without intervening action or debate. (*June 22, 2006.*)
