UNANIMOUS CONSENT AGREEMENTS

S. 3101 (ORDER NO. 772)

1.—*Ordered*, That at 9:30 a.m. on Thursday, June 12, 2008, the Senate resume the motion to proceed to S. 3101, a bill to amend titles XVIII and XIX of the Social Security Act to extend expiring provisions under the Medicare program, to improve beneficiary access to preventive and mental health services, to enhance low-income benefit programs, and to maintain access to care in rural areas, including pharmacy access, and for other purposes; provided, that the time until 3:00 p.m. be equally divided and controlled between the Leaders or their designees with the final 40 minutes of that time controlled as follows: 10 minutes each for the Senator from Iowa (Mr. Grassley), and the Senator from Montana (Mr. Baucus), the Senator from Kentucky (Mr. McConnell) and the Senator from Nevada (Mr. Reid) or their designees, in that order; provided further, that the vote on the motion to invoke cloture on the motion to proceed to S. 3101 occur at 3 p.m. on Thursday, June 12, 2008.

Ordered further, That the mandatory quorum required under Rule XXII be waived. (June 10, 11, 2008.)

S. 1974

2.—*Ordered*, That S. 1974, a bill to make technical corrections related to the Pension Protection Act of 2006, remain at the desk. (Mar. 31, 2008.)

VETO MESSAGE ON S. 5

3.—*Ordered*, That the veto message on S. 5, the Stem Cell Research Enhancement Act of 2007, be considered as read and that it be printed in the Record and spread in full upon the Journal.

Ordered further, That the message be held at the desk. (June 20, 2007.)

H.R. 3997

4.—*Ordered*, That if the Senate receives from the House a message on H.R. 3997, an act to amend the Internal Revenue Code of 1986 to provide earnings assistance and tax relief to members of the uniformed services, volunteer firefighters, and Peace Corps volunteers, and for other purposes, with an amendment that is not germane to the Senate amendment or the underlying bill, that the bill and its amendments be referred to the Committee on Finance.
