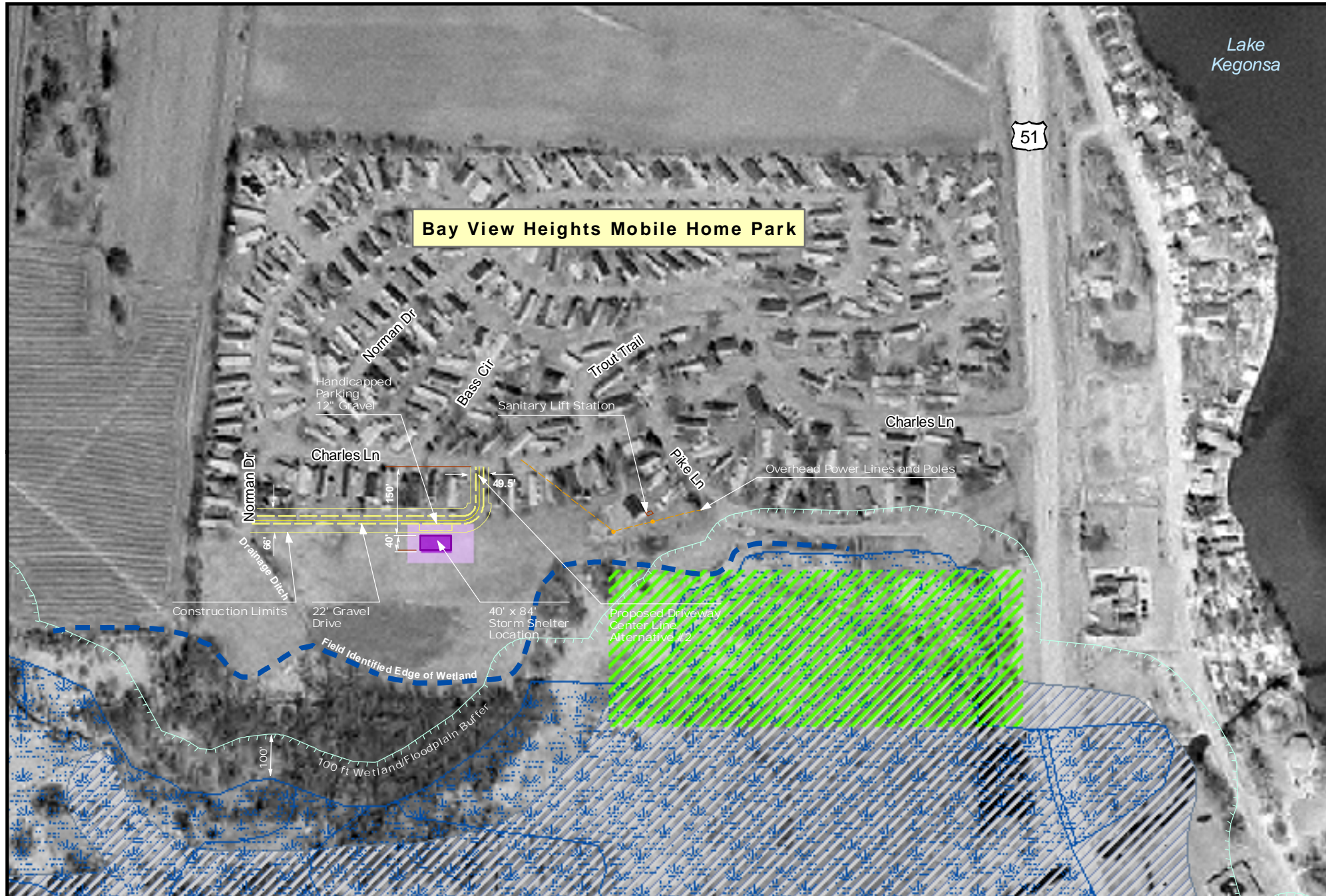

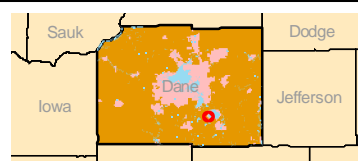

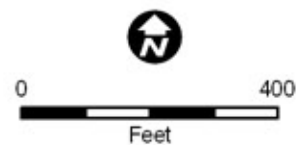

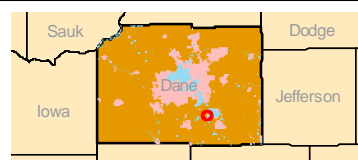

NOTES:

The Natural Resources Conservation Service (NRCS) was contacted regarding the proposed project and its applicability to the Farmland Protection Policy Act (FPPA). The project site contains soils classified as prime farmland, which is generally subject to the FPPA.

A Farmland Conversion Impact Rating form (AD-1006) was completed and resulted in a site assessment score of 58 for each alternative. Mr. Wacker of the Madison NRCS state office explained that the NRCS does not require the submission of form AD-1006 in cases where the site assessment criteria score (Part VI of the form) is less than 60 points for each alternative. 

The Corps previously sent notice to Susan Streich-Boldt, the State Hazard Mitigation Officer, advising that Corps would not have regulatory jurisdiction over this project, as there was no discharge of dredged or fill material into any water of the US, including wetlands. However, there seems to be impacts to a ditch, which may change jurisdiction on the part of the Corps and this project may be subject to Section 404 of the Clean Water Act.

The Corps of Engineers Regulatory Programs include Section 10 of the Rivers and Harbors Act of 1899 and Section 404 of the Clean Water Act. The St. Paul Districts regulatory jurisdiction covers the states of Minnesota and Wisconsin.

Under Section 10, a Corps permit is required to do any work in, over or under a Navigable Water of the U.S. Waterbodies have been designated as Navigable Waters of the U.S. based on their past, present, or potential use for transportation for interstate commerce. These waters include many of the larger rivers and lakes, such as the Minnesota, St. Croix, and Mississippi rivers; and Lake Superior and the Mississippi headwaters lakes.

Under Section 404, a Corps permit is required for the discharge of dredged or fill material into waters of the U.S. Many waterbodies and wetlands in the nation are waters of the U.S. and are subject to the Corps Section 404 regulatory authority.

Some ditches are considered a water of the U.S. by federal definition. Therefore, in order for me to determine which type of permit will authorize this proposed project, I will need the following information:

*More information about the drainage ditch on the western portion of the project site, such as, *please advise of the type of soil the ditch is located in, (I need to know if it is hydric. If it is, what is the hydric soil name?).

*the length, depth, width of the ditch, *how often the ditch has a flow of water in it, *the size of the wetland (sq.ft. or acres) that the ditch discharges to, *the waterway that the wetland discharges to, *does the wetland directly abuts this waterway, *what is the federally navigable waterway that is associated with the wetland and it's tributaries (see link for a list)

*Is photo #4 a photo of the ditch? I would like additional photos of this ditch and the location where it meets up with the wetland you refer to in your letter.

*The amount of aquatic impact under the ordinary high water mark (of any other water) will be _____ square feet/lineal feet/acres.

Since all Corps permits are based on the AMOUNT of aquatic impacts to wetlands and waters of the U.S., I will need this information before I can proceed with a jurisdictional determination which needs to be completed before issuing Department of the Army permit authorization.

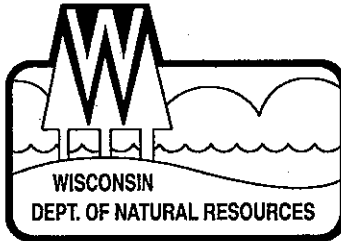

Dear Ms. Stavish,

The Bureau of Endangered Resources has reviewed the project area described in your review request received January 23, 2008 for the proposed "Town of Dunn Storm Shelter" in Dane County, WI.

Our Natural Heritage Inventory (NHI) data files contain the following information for the project site located in T6N R10E Section 26 in Dane County. In addition to the proposed project site, endangered resource information is provided for an area within one mile of the project's location (and two miles for aquatic species). This information is provided so impacts to nearby endangered resources can be assessed and to assist in determining which rare species may occur in the project's impact area. If the described habitat types exist in the project's impact area, then species that occur nearby may be present at the proposed location. Endangered resources documented within and around the project area include:

- **Wild hyacinth** (*Camassia scilloides*), a plant listed as Endangered in Wisconsin, is often located in moist prairie remnants, especially along roads and railroad rights-of-way. Flowering occurs from mid-April through late May. Optimal identification period is from mid-April to late May.

Our data files also contain historical records (generally, records that are 25 years old or older) of rare species known to occur within the vicinity of the project site. Unfortunately, the Bureau does not have more current survey information documenting the continued existence of this species in this area. These older records are included, however, as an indication of species which may occur in the project area if appropriate habitat still exists:

- **Prairie Vole** (*Microtus ochrogaster*), a state Special Concern mammal. This species is found in dry grassy areas along fence lines and in open fields; sandy prairies and slopes, especially if weed or grass grown; abandoned farm fields; seldom in sparsely wooded areas. Preferred habitat seems to be native prairie sod, of which there is little left in the State. It avoids marshes and wet places. Semi-colonial, this species breeds throughout the year with a peak in July, August and September.

Endangered and Threatened species are provided protection under the Wisconsin Endangered Species Law (29.604 State Stats.). Special Concern (Watch) species are those about which some problem of abundance or distribution is suspected but not yet proved. The main purpose of this category is to focus attention on certain species before they become endangered or threatened.

Comprehensive endangered resource surveys have not been completed for the project area. As a result, our data files may be incomplete. The lack of additional known occurrences does not preclude the possibility that other endangered resources may be present. Occurrences of rare species are only in our NHI database if the site has been previously surveyed for that species or group during the appropriate season, and an observation was reported and entered into the database. As such, absence of an NHI occurrence in a specific area should not be used to infer absence of rare species. Evaluations of the possible presence of rare species on the project site should be based on whether suitable habitat for the species exists within the project area.

Follow-up Actions:

1. The **Wild hyacinth** plant has been recorded within the vicinity of the project area and may occur on site if suitable habitat exists. However, there does not appear to be suitable habitat on the proposed development property. I recommend surveys be conducted for this species in surrounding areas if suitable habitat is found. Please contact our office for information on survey protocols if necessary.
2. The **Prairie Vole** is a historic record from the project area. Since the project site is maintained by mowing it is unlikely that the Prairie Vole is present. However, it may be present in surrounding areas with more suitable habitat. To minimize impact to surrounding habitat I recommend the limited use of chemicals and pesticides, including diazinon, on grassland habitats because of their known negative affects on reproduction and other aspects of small mammal biology.

The specific location of endangered resources is sensitive information that has been provided to you for the analysis and review of this project. Exact locations should not be released or reproduced in any publicly disseminated documents.

This letter is for informational purposes and only addresses endangered resource issues. This letter does not constitute Department of Natural Resources authorization of the proposed project and does not exempt the project from securing necessary permits and approvals from the Department.

On behalf of the Federal Emergency Management Agency (FEMA), URS is re-submitting information on the Town of Dunn Storm Shelter project for your review and comment.

This project was first initiated in early 2006 and has since been approved for the Pre-Disaster Mitigation-Competitive Grant Program. FEMA has determined that an Environmental Assessment (EA) is the appropriate level of NEPA documentation for the project. URS is currently preparing an EA on FEMA's behalf.


A Request for SHPO Comment and Consultation on a Federal Undertaking Form was previously submitted by Susan Streich-Boldt of Wisconsin Emergency Management (WEM) on March 2, 2006. Following this submittal your office requested additional information to include a land use history and evidence of previous disturbance. In response, WEM submitted a "previous land use and ground disturbance history" in a letter dated January 5, 2007. No response to this submittal is on file.

Since over a year has passed since previous consultation and because there have been modifications to the project, we now request an update of your previous review. The project is essentially the same as described in the original consultation; however, the location of the storm shelter has been further refined, and the location of the access road to the storm shelter has been changed to avoid potential impacts to wetlands.

A new Request for SHPO Comment and Consultation on a Federal Undertaking Form is enclosed requesting SHPO comments on our findings. Our findings have not changed from those Susan submitted last year. A revised project description and exhibits including site photos, an aerial photo, and a USGS map are also attached in addition to previous correspondence with SHPO. We were originally informed of the above referenced project by Ms. Susan Streich-Boldt of the Wisconsin Dept. of Military Affairs, Wisconsin Emergency Management office in March, 2006. After reviewing land use and additional site plan information provided in January and February, 2007, we recommended that an archeological survey be conducted for this project.

In January, 2008, we received correspondence from Ms. Nancy Stavish with the environmental consulting firm of URS Corporation, describing modifications to the project. We again recommended that an archeological survey be conducted.

We have now completed our review of the "Phase IA Assessment", which accompanied your letter dated April 18, 2008. We wholeheartedly agree with the recommendation that an archeological survey (Phase 1B survey) be conducted in all areas of proposed new ground disturbing activity, including those areas of previous agricultural activity. Agricultural activity, in and of itself, is not considered "ground disturbing" activity.


