Mogollon Rim District Urban Interface Structure Inventory

Since December 1998 we have been conducting Structure surveys on the District. Our first survey was taken on December 1998, then again in December 2001, three years from the previous one. We noticed a sizeable increase in structures at which time we decided to conduct these surveys every two years, January 2003 was our next one, and now the community has grown so fast we are now conducting these surveys on a yearly basis. We find these statistics to be very interesting and they are continually proving that our Urban Interface is growing much faster than we had anticipated. Recognition should be given to Darryl Atchison for compiling this information, we hope that you find it as interesting as we do.

Christmas Trees

We have 500 Christmas tree tags to sell "over-the-counter" this year. The first three days they were on sale the Information Center and the Blue Ridge Office sold almost 100. I am not sure how many we will have left by the time this newsletter comes out, but feel free to call our office or the Happy Jack Information Center if you have any questions. The

Christmas tree location is on Hospital Ridge this year with a lot of good fir trees. The tags cost \$10 each and are non-refundable. In the event we get a big snow and are forced to close the roads and unable to plow, we do not have any substitute trees available. Please keep this in mind when you purchase your tag. The Apache Sitgreaves National Forest also has Christmas Tree permits available. The permit will allow for the removal of one tree of any species up to ten feet tall from the Alpine, Springerville and Clifton Ranger Districts. At the time of purchase the purchaser will be given a detailed map with directions to the cutting areas.
