## Bar T Bar and Anderson Springs Management Plan

The final Environmental Impact Statement for Bar T Bar and Anderson Springs Allotment Management Plan has been completed and is available to look at. The final environmental impact statement (FEIS) describes the effects of implementing seven alternatives for livestock management on the Bar T Bar and Anderson Springs Allotments. The FEIS proposes
