**AREA CLOSURE**

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50 (a) the following act is prohibited on the area as described in this order, all within the Mogollon Rim Ranger District, Coconino National Forest until further notice. See map attachment, Exhibit A.

1. Possess or use any type of motor vehicle off National Forest System Roads, 36 CFR 261.56.

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons possessing or using aircraft, watercraft and over-snow vehicles;
2. Forest Service employees for limited administrative use;
3. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty; and
4. Person(s) with a permit specifically authorizing the other wise prohibited act or omission.

**AREA DESCRIBED:**

From the State Highway (SH) 87 and SH 260 intersection, proceed north along SH 260 to Forest Road (FR) 144. Closure area is east of SH 260 on this segment.

From intersection of FR144 and SH 260, proceed east along FR144 to the intersection of FR 149. Closure area is south of FR 144 on this segment.

From the intersection of FR 144 and FR 149, proceed north on FR 149 to the intersection of FR142. Closure area is east of FR 149 on this segment.

From the intersection of FR 149 and FR142, proceed east on FR142 to the intersection of FR 142 and SH87. Closure area is south of FR 142 on this segment.

From the intersection of FR 142 and SH 87, proceed north on SH 87 to the intersection of SH 87 and FR 141. Closure area is east of SH 87 on this segment.

From the intersection of SH 87 and FR141, proceed east on FR141 to the intersection of FR 141 and FR 300. Closure area is south and west of FR 141 on this segment.

From the intersection of FR 141 and FR 300, proceed west on FR300 to the intersection of FR 300 and SH 87. Closure area is north of FR 300 on this segment.

From the intersection of FR 300 and SH 87, proceed west on SH 87 to the intersection of SH 87 and SH 260. Closure area is north of SH 87 on this segment.

**PURPOSE:**

To eliminate the use that is causing resource damage.

**IMPLEMENTATION:**

1. This Order will be in effect when signed and shall remain in effect until September of 2009 when the Travel Management Rule is implemented.
2. A map identifying the closure area is attached and made part of this Order, see attached Exhibit A.
3. Any violation of this prohibition is punishable by a fine of not more than \$5,000.00 for individuals, and \$10,000.00 for organizations and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3559, Title 18 USC 3571, Title 18 USC 3581.
4. Order supersedes any previous orders prohibiting the same acts covered by this Order
