- 3 MS. SMITH: Good morning. My name is Rebecca
- 4 Smith. I'm the Associate Director of the Mine Safety and
- 5 Health Administration's, Office of Standards, Regulations,
- 6 and Variances. I will be the moderator for this public
- 7 meeting today.
- 8 On behalf of Dave Lauriski, the Assistant
- 9 Secretary of Labor for Mine Safety and Health, I want to
- 10 welcome you here today.
- 11 Also here today are several other individuals from
- 12 MSHA. To my left, Dr. Carol Jones is our program manager
- 13 for our health division for metal, nonmetal. Wendy Hoch is
- 14 from our technical support center. Al Ducharme is from our
- 15 solicitor's office. On my right, Carlos Mosley is from our
- 16 coal organization. And Jim lynch is from MSHA's standards
- 17 office.
- 18 This is the second of seven public meetings. The
- 19 first meeting was held on May the 2nd in Pittsburg,
- 20 Pennsylvania. The remaining meetings will be held on May
- 21 16th in Vacaville, California; May 29th in Canton, New York;
- 22 June 5th in Phoenix, Arizona; June 12th in Virginia,
- 23 Minnesota; and, June 20th in Charlottesville, Virginia.
- 24 The initial announcement of these meetings was
- 25 contained in the Advanced Notice of Proposed Rule Making,

- 1 published on March the 29th, 2002 in the Register.
- 2 A subsequent Federal Register Notice published on
- 3 April the 18th, announced that the date of the
- 4 Charlottesville, Virginia meeting was changed to June 20th
- 5 and a public meeting would be held in Phoenix, Arizona on
- 6 June the 5th. These two Federal Register Documents are
- 7 available to you in the back of the room.
- 8 The purpose of these meetings is to obtain
- 9 information from the public that will help us evaluate the
- 10 following five issues.
- 11 Number one, whether to lower our asbestos
- 12 permissible exposure limit.
- Number two, whether we should replace our existing
- 14 fiber analysis method referred to as Phase Contrast
- 15 Microscopy with a more sensitive method, which is
- 16 Transmission Electron Microscopy.
- Number three, whether we should implement
- 18 safeguards to limit take-home exposures.
- 19 Number four, whether our field sampling methods
- 20 are adequate and how our sampling results are being used.
- 21 And number five, what is the likely benefit and
- 22 cost impact of any rule making action we would take on these
- 23 issues.
- 24 These five issues were discussed in the March 29th
- 25 Federal Register Document. The scope of the issues we are

- 1 addressing with this Advanced Notice of Proposed Rule Making
- 2 is limited. Therefore, this public meeting will be limited
- 3 to hearing public input on the five issues I just mentioned.
- In the Advanced Notice of Proposed Rule Making, we
- 5 asked several questions related to each of these five
- 6 issues. And we're particularly interested in responses and
- 7 information relating to the these questions.
- Now, I'd like to give you some background which
- 9 has led us to be here today. MSHA's current asbestos
- 10 standard for coal mining and for metal and nonmetal mining
- 11 is two fibers per cubic centimeter of air. And these
- 12 standards date from the mid-1970s.
- In 1980 we requested that the National Institute
- 14 for Occupational Safety and Health, or NIOSH, investigate
- 15 health problems at vermiculite operations around the
- 16 country, because our sampling data at that time showed
- 17 higher than average asbestos exposure among minors.
- 18 The results of the NIOSH study were published in
- 19 1986 and verified our sampling results that indicated high
- 20 occupational exposure prior to 1974 at a vermiculite
- 21 operation in Libby, Montana.
- The highest exposures were in the mill. The NIOSH
- 23 report showed that in 1974, the mine began to use a wet
- 24 process to concentrate vermiculite in the mill, and
- 25 occupational exposures dropped remarkably.

- 1 The asbestos-exposed miners employed at the
- 2 vermiculite mine in Libby, Montana; however, inadvertently
- 3 carried asbestos fibers home on their clothes and in their
- 4 personal vehicles, thereby continuing to expose themselves
- 5 and family members.
- At that time, we had encouraged the operator to
- 7 change from dry to wet processing of material and also to
- 8 reduce take-home contamination by installing showers and
- 9 requiring the miners to change clothing before leaving the
- 10 site.
- In November of 1999, a Seattle newspaper published
- 12 a series of articles about the unusually high incident of
- 13 asbestos-related illnesses and fatalities among individuals
- 14 who had lived in Libby, Montana.
- 15 Because MSHA had jurisdiction over the mine, the
- 16 Department of Labor's Office of the Inspector General began
- 17 evaluation of MSHA's role at the Libby mine. The findings
- 18 and recommendations of the Office of the Inspector General
- 19 was published in March of 2001. Three of their
- 20 recommendations would require additional rule making by
- 21 MSHA, and those issues are the subject of this public
- 22 meeting today.
- 23 These Office of Inspector General recommendations
- 24 were that MSHA lower the existing permissible exposure limit
- 25 to a more protective level, that MSHA use a more sensitive

- 1 method, Transmission Electron Microscopy, to quantify and
- 2 identify fibers in our samples rather than the Phase
- 3 Contrast Microscopy method currently used, and that MSHA
- 4 address take-home contamination from asbestos.
- 5 Recently, MSHA adopted new asbestos sampling
- 6 techniques, and we have increased the scope of sampling from
- 7 airborne asbestos fibers at mines in an attempt to better
- 8 determine miners' exposures to levels of asbestos.
- 9 Our efforts have included taking samples at all
- 10 existing vermiculite, taconite, talc, and other mines to
- 11 determine whether asbestos is present and at what levels.
- 12 Since the spring of 2000, we have taken almost 900
- 13 samples at more than 40 operations employing more than 4,000
- 14 miners. Our preliminary review and analysis of these
- 15 samples showed that there are very few exposures occurring
- 16 during the sampling period which were above the OSHA
- 17 eight-hour timeline average of .1 fiber per cubic centimeter
- 18 of air.
- 19 The sampling results are now available to the
- 20 public on our web site at www.msha.Gov. Also, the sampling
- 21 results will be made part of the rule-making record, if we
- 22 move forward.
- 23 The issues surrounding asbestos exposure are
- 24 important to MSHA, and we will use the public meetings to
- 25 help decide how best to proceed to address these five

- 1 issues. So we want to hear the public view.
- These meetings will give mine operators, miners,
- 3 and their representatives, and other interested parties an
- 4 opportunity to present their views on these five issues that
- 5 we are considering for potential rule-making action.
- The format of this meeting will be as follows:
- 7 formal rules of evidence will not apply, and this meeting
- 8 will be conducted in an informal manner. Those of you who
- 9 have notified us in advance of your intent to speak or have
- 10 signed up today to speak, will make your presentations
- 11 first. After all scheduled speakers have finished, others
- 12 can request to speak. When the last speaker is finished, we
- 13 will conclude this public meeting.
- 14 If you wish to present any written statements or
- 15 information today, please clearly identify your material,
- 16 and when you give it to us, we will identify it so for the
- 17 record.
- 18 You may also submit comments following the
- 19 meeting. And please submit those to us by June 27th, which
- 20 is the close of the comment period. Comments may be
- 21 submitted to us by electronic mail, fax, or regular mail.
- 22 Please note that our headquarters in Arlington,
- 23 Virginia will be moving on June the 10th, and therefor we
- 24 have new address, telephone, and fax information. And that
- 25 new information is also available to you in the back of the

- 1 room.
- 2 A verbatim transcript of this public meeting will
- 3 be available upon request. If you want a personal copy, you
- 4 may make arrangements with the court reporter, or you may
- 5 view it on our web site. It will be posted there within
- 6 five days of the close of this public meeting. The
- 7 procedures will be the same for each of the other public
- 8 meetings.
- 9 We will begin with persons who have requested to
- 10 speak. And to assure that we obtain an accurate record,
- 11 when you speak, please begin by clearly stating your name
- 12 and organization for the record. Our first speaker this
- 13 morning is Judy Olson. Judy.
- 14 MS. OLSON: Good morning. My name is Judy Olson.
- 15 I'm the Eastern Washington Director for U.S. Senator Patty
- 16 Murray here in the Spokane office. And I'd like to thank
- 17 you for holding this hearing here in Spokane. We very much
- 18 appreciate it. This morning I have some comments that I
- 19 would like to make on behalf of Senator Murray.
- 20 Senator Murray is very concerned about what has
- 21 happened in Libby, Montana. This issue resonates for people
- 22 here in Spokane for a couple of reasons. The first is that
- 23 a lot of people from Libby have moved here and have received
- 24 medical care in this community. Libby is only 160 miles
- 25 from Spokane.

- 1 Second, during the 1950s and 1960s, Vermiculite
- 2 Northwest Incorporated had a plant here in Spokane which
- 3 processed vermiculite from Libby.
- 4 Last summer Senator Murray held a hearing on
- 5 Asbestos and Workplace Safety in the Senate Health Education
- 6 Labor and Pension or HELP Committee. Dr. Alan Whitehouse, a
- 7 chest physician and pulmonologist, from Spokane testified at
- 8 this hearing in Washington, D.C.
- 9 He has treated approximately 400 people from Libby
- 10 in varying -- with varying degrees of lung damage caused by
- 11 exposure to asbestos. Approximately 25 percent of his
- 12 patients never worked for or had a family member who worked
- 13 for W.R. Grace. Their only exposure to asbestos in Libby
- 14 was environmental. Five of his patients who were exposed
- 15 only to asbestos in the environment have died.
- 16 Senator Murray hopes that MSHA will -- is making
- 17 asbestos and other harmful mineral fiber exposures at mines
- 18 throughout the country a very high priority. Senator Murray
- 19 is glad that you are holding these public meetings, but
- 20 hopes that the agency will follow up with rule making in a
- 21 reasonable time frame, hopefully by the end of the year.
- 22 Like so many others, Senator Murray is struggling
- 23 to understand how Libby could have happened, despite all of
- 24 the laws and regulations already in place to protect miners
- 25 and workers.

- 1 She strongly supports implementing as soon as
- 2 possible the recommendations made by the Department of
- 3 Labor's Inspector General well over a year ago.
- 4 Lowering MSHA's permissible exposure limit for
- 5 asbestos to match OSHA's. Currently, the limit is 20 times
- 6 that -- 20 times weaker -- excuse me. Currently, MSHA's
- 7 limit is 20 times weaker than -- this doesn't make sense.
- 8 Somebody else wrote it. Anyway, it refers to the limits on
- 9 -- of centimeters per cubic centimeter of fiber. Use more
- 10 precise methods to measure asbestos and to address the
- 11 take-home contamination from asbestos.
- 12 Senator Murray believes that implementing the
- 13 Inspector General's recommendations is an important first
- 14 step in strengthening the protection of miners, their
- 15 families, and surrounding communities.
- She hopes that MSHA will consider expanding its
- 17 review to include the nonregulated asbestos minerals such
- 18 as, winchite and richterite and nonasbestos from a variety
- 19 of regulated forms. These other forms have also been found
- 20 in Libby.
- It may be that our current regulatory framework
- 22 doesn't protect people well enough because of the narrow
- 23 definition of asbestos currently in place.
- The name of the mineral is far less important than
- 25 whether there is evidence suggesting fibers of certain

- 1 dimensions pose threats to human health.
- 2 Senator Murray will submit a more detailed written
- 3 comment for the record. Senator Murray is currently working
- 4 on legislation to ban asbestos in consumer products. The
- 5 bill will make it illegal by 2005 to deliberately or
- 6 knowingly produce products containing asbestos, the six
- 7 currently regulated forms.
- 8 The bill also requires EPA to create a blue ribbon
- 9 panel within -- from MSHA, NIOSH, and OSHA to provide
- 10 recommendations on asbestos and currently nonregulated
- 11 minerals.
- 12 Senator Murray's hoping to introduce the bill in
- 13 the next couple of weeks. If anyone would like more
- 14 information about Senator Murray's work on asbestos, they
- 15 can visit her web site at www.murray.senate.gov. The site
- 16 provides a link to the Health Education Pensions Committee.
- 17 If you have any specific questions about the draft
- 18 legislation, anyone should contact Anna Knudson, Senator

- 20 Thank you very much for providing this opportunity
- 21 for Senator Murray to present her comments. Thank you.
- MS. SMITH: Thank you, Ms. Olson. Could you spell
- 23 Ms. Knudson's last name for us.
- 24 MS. OLSON: Yes, I will. Anna Knudson,
- 25 K-n-u-d-s-o-n.

- 1 MS. SMITH: Thank you. Before you leave, Ms.
- 2 Olson, do any of the panel members have any questions for
- 3 Ms. Olson? Thank you, very much.
- 4 MS. OLSON: Thank you again. And the Senator will
- 5 be providing written comments.
- 6 MS. SMITH: Thank you, very much. At this time,
- 7 we do not have any other speakers who have indicated an
- 8 interest in presenting information. So we will go off the
- 9 record at this point, and we will remain. And if we do have
- 10 other speakers come in, we will go back on the record at
- 11 that time. Thank you.
- 12 (Recess.)
- MS. SMITH: We're going to go back on the record
- 14 for just a second. It's 10 o'clock. We don't have any
- 15 other speakers signed up as yet. What we'll do is, we'll
- 16 stay until 11 o'clock. If we have no other speakers by 11
- 17 o'clock, we'll close the record officially. So we'll go
- 18 back off the record now.
- 19 (Recess.)
- MS. SMITH: We're back on the record. It's 11
- 21 o'clock. We have no further speakers indicating an interest
- 22 to present information, so we're going to officially close
- 23 the record on this public meeting. Thank you.
- 24 (Whereupon, the hearing concluded at 11:03 a.m.)
