Gleason's Landing Campground and watercraft rest stop is located on the Pere Marquette National Wild and Scenic River. The campground is very popular with campers, anglers, and river users. The rest stop area is accessible by water, has grills and benches and is used on a first come, first serve basis.

## LOCATION

Gleason's Landing Campground is located in Lake County, Michigan. The nearest community is Baldwin, about 3 miles northeast.

## NATIONAL FOREST ACCESS

**From Baldwin:** Take 7th Street west 5 blocks to Cherry Street, then south 1.5 blocks to 52nd Street (Carr Road). Go west about 2 miles to Jenks Road, then south 1/2 mile to Shortcut Road. Finally, go southwest about 1 mile to 60th Street, west 1/2 mile to Brooks Road, and south about 1 mile to the site.

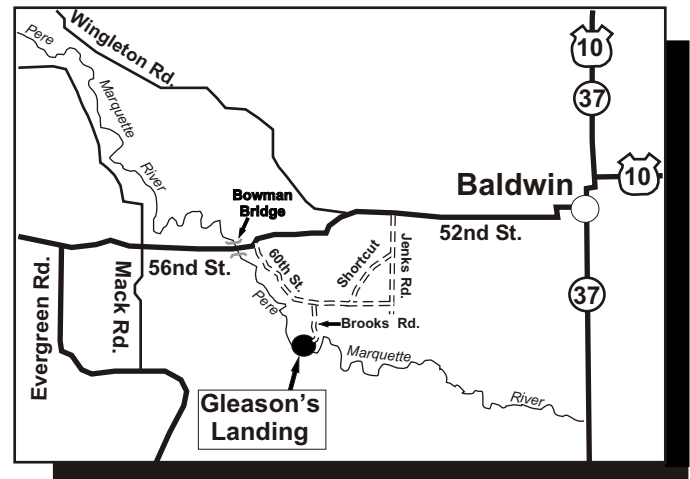

## SEASON

The season is from Memorial Day through Labor Day weekend. The area may be opened earlier and/or closed later, depending on need. Please check with the Baldwin Ranger Station regarding dates outside the managed season (231-745-4631). The canoe landing is open year-round. It is snow-plowed in winter.

## FEES

The campground is operated by a concessionaire under a special-use permit. All campsites may be reserved by calling 877-444-6777. Family sites accommodate up to 8 people and group sites up to 20 people. Please contact the Baldwin Ranger Station office for a list of fees.



## CANOE LANDING FEES

A Huron-Manistee National Forest vehicle pass is required at the canoe landing. Daily passes may be purchased at the site. Weekly and annual passes may be purchased at the Baldwin Ranger Station or at participating vendors. Please contact the Ranger Station for this list or further details.

## CONSIDERATIONS

Gleason's Landing Campground is for walk-in tent camping only. No motor vehicles are allowed with the campground or picnic area. Camping is allowed at designated sites only.

Gleason's Landing is used by local liveries under a special-use permit from the Forest Service. Please be considerate and park in designated areas.

Please collect only dead and down wood for your campfire. It is illegal to cut live trees.

A campground host who resides at Bowman Bridge Campground visits the site daily. during the camping season.

A watercraft permit is required for all river users from May 15 to September 10. Permit hours are 9:00 a.m. to 6:00 p.m. Permits can be obtained by reservation or walk-in at the Baldwin Ranger Station (231)745-4631.
