LOCATION

Pines Point Campground is located in Oceana County, Michigan. The nearest community is Hesperia, Michigan.

NATIONAL FOREST ACCESS

From Hesperia: Go west on Hwy. M-20 to 192nd Ave. Turn south for 1 mile to Garfield Road. Turn right (west) and go 3 miles. Turn left (south) on 168th Avenue (Forest Road 5118). Follow the blacktop road to the campground.



SEASON

The camping season is from Memorial Day through Labor Day weekend. The area may be opened earlier and/or closed later, depending on need. Please check with the Baldwin Ranger Station regarding dates outside the managed season (231-745-4631).

FEES

The campground is operated by a concessionaire under a special-use permit. Most family campsites are first come, first serve. Group, and some family campsites may be reserved by calling 877-444-6777. Family sites accommodate up to 8 people and group sites up to 20 people. Please contact the Baldwin Ranger Station office for a list of fees.



CANOE LANDING FEES

There is a \$3.00 per vehicle day use fee for use of the watercraft landing and picnic area. These areas are also under the concessionaire permit.

CONSIDERATIONS

Group site camping is by tent only. All sites are walk-in.

There is no electricity or showers at this site.

Please collect only dead and down wood for your campfire. It is illegal to cut live trees.

There is a campground host who resides on site number 29 during the camping season. Campfire wood is often available for sale.
