Sulak site is located on the Pere Marquette Wild and Scenic River just south of Branch and near Upper Branch Landing Site. The site is jointly managed by the U.S. Forest Service and the Michigan DNR. The site offers an improved landing with a large parking area near the river. Downstream the site offers angler walk-in fishing access as well as 12 primitive campsites. The campsites are managed by the Forest Service. This is a very popular area to fish during the spring and fall salmon runs. It is also a popular river put-in and take-out, as well as a rest stop for those floating the river.

LOCATION

Sulak site is located in Lake County, Michigan. The nearest community is Branch, about 3 miles northwest.

NATIONAL FOREST ACCESS

From Branch: Take US-10 to Branch (Tyndall Road) and go south ½ mile to W. Stevenson Rd. Turn east until the road turns into South Branch Road. Follow South Branch Rd. over the river and up a steep hill. At the next bend in the road you will see a Michigan DNR sign for a Landing. This is Sulak. Turn south and follow the gravel road to the campsites and further on to the landing site.


From Baldwin: Take 7th Street west 5 blocks to Cherry Street, then south 1½ blocks to 52nd Street. 52nd Street becomes 56th St. (also known as Carrs Rd.). Follow for about 8 miles to South Branch Road. Turn north on South Branch Road and travel approx. 2½ miles to Sulak. You will see a Michigan DNR landing sign at the gravel road which goes north to the site.

FACILITIES AVAILABLE

- 11 Primitive Family Campsites
- 11 Fire Rings
- 1 Vault Toilet at Angler Access/Campsite Areas
- 1 Vault Toilet at Landing
- A large parking area for landing area.

SEASON

The managed season is from May through October. However, the area is not officially closed at any time during the year. It is not snow plowed in



winter. Please check with the Baldwin Ranger Station regarding dates outside the managed season and conditions at the site if questionably (231-745-4631).

CAMPING

Camping is restricted to the eleven designated sites. You must occupy the site the first night and may not leave your camp equipment unattended for longer than 24 hours. The campsites are first come, first serve.

HURON-MANISTEE VEHICLE PASS

At this time there are no campsite fees at the site.

CONSIDERATIONS

The Sulak Angler Access site is used by local liveries under a special-use permit from the Forest Service. Please be considerate and park in designated areas.

Care should be taken to keep the area clean and in the condition it was found, so visitors are asked to please pack out what you pack in. Drinking water is not provided.

For State Fishing Regulations Consult the DNR website: www.dnr.state.mi.us. A permit is required for commercial use of National Forest lands.

Please collect only dead and down wood for your campfire. It is illegal to cut live trees.
