Timber Creek Campground is a developed campground located on Tank Creek. The campground is completely surrounded by National Forest land and is a nice location for solitude and enjoying the beauty of nature. Year-round, the Timber Creek Campground serves as a North Country National Scenic Hiking Trailhead. In the winter, it serves as a parking area for those accessing the Ward Hills Snowmobile Trail.

LOCATION

Timber Creek Campground is located on US-10 in Lake County, Michigan. The nearest community is Branch, about 2 miles west.

NATIONAL FOREST ACCESS

From the north: Take M-37 south about 20 miles from its junction with M-55, then right on US-10 for about 7 miles. Turn right on Forest Road 5198, which is the entrance to the site.

From the south: Travel north on M-37 to its junction with US-10 in Baldwin, then left on US-10 for about 7 miles. Turn right on Forest Road 5198, which is the entrance to the site.


From the west: Travel east on US-10 from its junction with US-31 to Branch. Continue east on US-10 approximately 2 miles. Turn left on Forest Road 5198, which is the entrance to the site.

SEASON

The camping season is from Memorial Day through Labor Day weekend. There are no reservations taken (occupancy is on a first come, first serve basis). Campsites can accommodate up to 8 people and 2 vehicles. Please contact the Baldwin Ranger

<u>FEES</u>

A Huron-Manistee National Forest vehicle pass is required at this site. Weekly and Annual passes can be purchased at the Baldwin Ranger Station and at local designated vendors. Please contact the Baldwin Ranger Station office for a list of fees.

CONSIDERATIONS

There is no electricity or showers at this site.

Please collect only dead and down wood for your campfire. It is illegal to cut live trees.

Care should be taken to keep the area clean and in the condition it was found, so visitors are asked to please pack out what they pack in.

Off-road vehicles are not allowed in Timber Creek Campground. The Little O ATV Trailhead is located on 32nd Street in Baldwin.

There is no campground host residing in this campground.

This campground provides easy access for those visitors embarking on activities on the Pere Marquette River.
