One of the most popular campgrounds in Manistee County, Sand Lake offers a wide variety of camping experiences. Both wooded and open campsites are available for families and groups. The clean sandy beach is a great attraction while camping or for a day visit.

LOCATION

Sand Lake Campground is located in Manistee County, Michigan. The nearest community is Dublin, about 1 mile north.

NATIONAL FOREST ACCESS CAMPGROUND

From the north, turn south off M-55 at Wellston onto Seaman Road. Follow Seaman Road about 4.5 miles through Dublin to the entrance road. Turn right on the Forest Road 5728 (Sand Lake Road) to the campground.


From the south, turn off M-37 about 10 miles north of its intersection with US-10 at Baldwin. Go 2 miles west on 4 Mile Road, turn north (right) on Irons Road and go about 7 miles to 10 ½ Mile Road. Then go west 1 mile to Seaman Road. Follow north for about 3 miles to the entrance road (Sand Lake Road).

SEASON

The managed season is Memorial Day weekend through Labor Day. The area may be opened earlier and/or close later, depending on need. Please check with the Manistee Ranger Station regarding dates outside the managed season (231-723-2211 or TTY 231-723-0124).



FEES

For the latest information regarding fees and condition of the facility, contact the Manistee Ranger Station. A maximum of 8 people and 2 vehicle is permitted at each family campsite. Site 32 accommodates 16 people and 2 vehicles. A group site for up to 25 people and 6 vehicles is available. Reservations may be made by calling Reserve America at (877) 444-6777.

CONSIDERATIONS

Care should be taken to keep the area clean and in the condition it was found, so visitors are asked to please pack out what they pack in.

Please collect only dead and down firewood for campfires. It is illegal to damage or cut live trees.
