## MEMORANDUM FOR ALL CAP COMMANDERS

SUBJECT: Interim Change Letter – CAPR 50-17, CAP Senior Member Professional Development Program

- 1. The 2008 Winter National Board approved revising CAPR 50-17 to broaden the list of professional development resident courses that can be used to satisfy "staff or director" duty requirements for completion of Levels IV and V of the Senior Member Professional Development Program.
- 2. Currently, only those members who serve as a staff member of a Squadron Leadership School (SLS), Corporate Learning Course (CLC), or Unit Commanders Course (UCC) can receive credit toward completion of Level IV requirements. And, only those members who serve as a staff member of a Region Staff College (RSC) or National Staff College (NSC), or the Director of an SLS, CLC, or UCC can receive credit toward completion of Level V requirements.
- 3. In view of the above, the Winter National Board approved expanding the list of professional development courses that qualify for achievement of Level IV and Level V director/staff requirements. To qualify as an approved course, the course must have at least 12 hours of contact time and provide the opportunity for senior members to serve as a staff member or director. I have reviewed the list of courses recommended by the NHQ staff and expanded the list to include director/staff opportunities in support of wing, region and national cadet and aerospace education courses and education/training activities of 12 hours or more. The final decision on awarding director/staff credit is vested in the approval authorities for Levels IV and V as specified in CAPR 50-17. For Level IV the approval authority is the wing commander and for Level V the approval authority is the region commander.
- 4. To implement this policy change, paragraph 6-1 and paragraph 7-1 of CAPR 50-17 will be revised to reference a single list of director/staff duty opportunities. The list will become a new Attachment (number 14) to CAPR 50-17. I have enclosed it for your reference. Also, Attachment 1 to CAPR 50-17, *CAP Senior Member Professional Development Program Progression and Awards*, will be updated to reference the new Attachment 14 to CAPR 50-17. All of the aforementioned changes in this letter will be incorporated into CAPR 50-17 when revised.
