SUBJECT: Liability Insurance Requirements for CAP Glider Maintenance

REFERENCE: My 18 December 2007 letter, Policy Updates Regarding Conflicts of Interest and Insurance Coverage for Maintenance of CAP Corporate Aircraft (http://level2.cap.gov/documents/2007 12 18 ins coverage mx.pdf)

- 1. NHQ CAP/MXA has received several inquiries regarding the practical ability of glider repair shops to meet our liability insurance requirements that we established for powered aircraft. After a careful review of our glider safety record and our liability risks, it is evident that these requirements may be reduced for our glider operations.
- 2. Aircraft mechanics that perform maintenance and/or repairs on CAP corporate-owned gliders are required to carry liability insurance with minimum policy limits of \$500,000 per occurrence instead of \$1 million. All other requirements of my 18 December 2007 letter referenced above apply. The \$1 million liability insurance requirement for mechanics servicing CAP's powered aircraft remains in effect.

Before a maintenance facility or mechanic may perform any maintenance on any CAP glider, a current certificate of insurance, identifying the liability insurance coverage must be forwarded to NHQ CAP/MXA for approval. Additionally, a copy of the certificate must be on file with the wing or region. Copies may be faxed to 334-953-1668 or mailed to NHQ CAP/MXA, 105 S. Hansell St, Maxwell AFB, AL 36112.

- 3. The attached fax request may assist your mechanic in obtaining the certificate of insurance that we are seeking.
