MEMORANDUM FOR REGION AND WING COMMANDERS

SUBJECT: Air Force Junior Reserve Officer Training Corps (AFJROTC) Orientation Flight Program

- 1. CAP has received final approval for the AFJROTC Flight Program so we are now ready to begin flying orientation sorties. Please make sure your people are aware of the following very important points of emphasis about the AFJROTC program:
- a. AFJROTC units will contact CAP wings if they want to participate. They have a list of CAP contacts (see attached HQ AFJROTC letter) for this purpose.
- b. AFJROTC cadets are authorized to receive only one orientation flight regardless of where the cadet sits -- front or rear seat. The sortie profile may include a combination of Flight No. 1 and Flight No. 2 as described in the Orientation Flight Syllabus (excerpt from FY08 Memorandum of Agreement is attached. The complete MOA can be downloaded at http://level2.cap.gov/documents/AFROTC.pdf) All flights should be one hour or less. The mission symbol for AFJROTC orientation flights is A8.
- c. Prior to flying with CAP, AFJROTC units will make sure the cadet's parents fill out a release form. AFJROTC units will keep these forms on file.
- d. AFJROTC has specifically stated that they <u>will not allow reimbursement for ferry flights</u> this year in order to maximize the use of funds allocated on orientation flights. Note this is different from what the Memorandum of Agreement states and CAP must comply with this modification. This means CAP flying units who are located close to an AFJROTC unit are the primary ones who will be able to participate in the program.
- e. <u>AFJROTC</u> flights must be entered into WMIRS before the orientation flight is flown in order to make sure there are funds available. The flight should be entered just like any other flight that is approved under the Air Force monthly "A" mission number in WMIRS. If the AFJROTC unit is not listed in the sortie drop down menu, this means the AFJROTC unit has either not been approved to participate in the program yet or there is no more funding remaining for that unit. HQ AFJROTC is approving funding for only a few sorties per unit because they have so many units to accommodate. CAP units must enter flights in advance and go through the pre-flight budget check in WMIRS or they will not be reimbursed.
- f. The budgets distributed to the AFJROTC units include minor maintenance funds. Even if your wing participates in the consolidated maintenance program, WMIRS will automatically account for the total cost of the flight when it runs its budget check.

AFJROTC Orientation Flight Syllabus (Excerpt from FY08 MOA)

Note: only one flight per year is authorized per AFJROTC cadet. The flight can be either profile below or a combination of the two.

I. Flight No. 1 -- Preflight Inspection, Takeoff, and Landing. The pilot will perform the following duties:

a. Preflight: Brief IAW the checklist at Attachment 3 to Annex B. Discuss the basics of light aircraft aerodynamics. Using the appropriate aircraft checklist, demonstrate routing of preflight inspections, showing the cadet what is inspected, what to look for, and why.

b. Before Takeoff:

- (1) Using the checklist, show cadets how routine cockpit checks are made prior to takeoff.
- (2) Point out procedures in starting the engine and the safety precautions to be observed.
- (3) Describe the use of controls while taxiing and point out safety precautions to be observed.
- (4) Explain selection of runway and engine run-up.

c. In Flight:

- (1) Point out familiar position and attitude of the aircraft in normal flight with various throttle and control positions.
- (2) Point out familiar landmarks, prominent ground features, and position of airport with respect to surrounding community.
- (3) Describe approach to traffic pattern, explain reasons for contact with control tower or transmissions on common air traffic frequency at uncontrolled fields. Call attention to correct procedure for entering traffic pattern, glide angle, normal landing, taxiing aircraft to parking area, and engine shutdown.
 - d. Post Flight: Answer questions pertaining to the flight and stress safety.

II. Flight No. 2 -- Normal Flight Maneuvers:

- a. Preflight: Brief IAW the checklist at Attachment 3 to Annex B. Discuss Flight No. 1 as appropriate.
- b. In Flight: The pilot will perform the following flight maneuvers at a minimum altitude of 2500 feet above ground level (AGL):
- (1) Point out how aircraft will regain normal attitude "hands-off" from a shallow (not to exceed 5 degrees of pitch) climb or dive. Demonstrate use of trim controls.
 - (2) Point out how aircraft will maintain turn, with controls neutral.
 - (3) Demonstrate effects of drift and methods of corrections.
 - (4) Demonstrate coordinated and uncoordinated shallow turns.
 - (5) Demonstrate straight and level flight, flying with visual reference to checkpoint and horizon.
 - c. Post Flight: Answer questions pertaining to the flight and stress safety.

SUBJECT: CAP Flight Orientation Program

- 1. Headquarters Air Force recently granted Civil Air Patrol (CAP) approval to provide AFJROTC cadets orientation flights. This message provides information on the CAP Flight Orientation Program (FOP) and how to request sorties from your nearest CAP unit. (Attachment 1 is the Memorandum of Agreement between CAP and HQ AFJROTC authorizing the orientation flights.)
- 2. The CAP FOP is an additional source for units to obtain cadet orientation flights. If the local CAP unit cannot provide sorties, units are encouraged to work with the Experimental Aircraft Association Young Eagles, base aero clubs, or Fixed-Base Operators to obtain flights. Attachment 2 is the list of CAP units located across the United States. Prior to flying with the CAP, units need to fill out the release form at Attachment 3 -- Cadet Orientation Flight Release, Indemnity, and Assumption of Risk waiver verifying parent/guardian permission for cadets to participate in the FOP.
- 3. Headquarters has set aside funds to support the CAP FOP through the remainder of this fiscal year. Units that would like to take advantage of this opportunity will need to contact Mr. Paul Keeping at e-mail Paul.Keeping@maxwell.af.mil to request funding authorization. Since we are working with a finite pot of money, units will receive a fair share allocation of the funds available. Units not able to participate in the CAP FOP will be able to participate in the Cadet Flight Orientation Program by submitting request for support through Cyber Campus during the annual Open Season.
- 4. Units with CAP squadrons within a reasonable driving distance capable of providing sorties can contact them to set up/schedule cadet orientation flights after receiving funding approval. Under no circumstances are AFJROTC units authorized to request CAP to ferry aircraft to their location to participate in the FOP. Be sure to review the AFJROTC Cadet Orientation Flight Syllabus with the pilot prior to the first flight to ensure a thorough understanding of our flight safety concerns and requirements.
- 5. After the Orientation Flight, CAP will send your unit an auto email verifying flight information and cost. Confirm that the information is accurate and the agreed to funding limit was adhered to. If the information is correct, send the e-mail to Mr. Keeping who will arrange to pay CAP. Units must coordinate closely with the CAP squadron to stay within authorized spending limits.

6. This fall, headquarters will provide information on a combined Cadet Flight Orientation Program that will include both CAP and alternative flight providers. The program will allow units to request orientation flight support from either CAP or other providers. The two programs will not compete for funds, however funds will still be fair shared between those units asking for support. Those units utilizing alternative flight providers will coordinate the use of the Government Travel Card (GTC) prior to the flight or request reimbursement after the flight. More information and guidance will be published before the start of the next academic year. In the mean time, I encourage every unit that can take advantage of the CAP FOP opportunity to do so. The academic (ground) phase of instruction will include basic flight planning procedures, aerodynamics, aircraft structures, and aviation safety procedures.
