FACTS AND FIGURES

Personnel

- ▶ 94 U.S. Marshals, one for each federal court district
- ▶ 3,200 Deputy Marshals and Criminal Investigators
- ▶ 1,400 administrative employees and detention enforcement officers
- ▶ Total employees: Approximately 4,700
- ▶ 94 districts; 218 sub-offices; three foreign field offices

Fugitive Apprehension

- ▶ Arrested more than 36,000 federal fugitives, clearing 38,900 felony warrants
- ▶ Arrested more federal fugitives than all other DOJ law enforcement agencies combined
- ▶ USMS-led fugitive task forces arrested more than 56,600 state/local fugitives, clearing 70,329 state/local felony warrants
- ▶ 185 15 Most Wanted fugitives have been captured since 1983
- ▶ Extradited/deported 772 fugitives from 64 countries in FY2007
- ▶ 5,970 special deputations since October 2005
- ▶ Almost 39,000 felony warrants received; more than 36,000 federal fugitives arrested
- ▶ Under the Adam Walsh Child Protection and Safety Act, enacted in FY2006, Marshals apprehended over 7,300 sex offenders in FY2007

- ▶ Additionally, 920 cases were initiated with 240 warrants issued and 183 arrested for violating the new law

Justice Prisoner and Alien Transportation

- ▶ 390,000 federal prisoner movements
- ▶ Over 244,000 movements by air
- ▶ Over 3,600 non-federal prisoner movements

Judicial Security

- ▶ Provides a 24/7 response capability for intake and review of threats against the judiciary through the newly constructed Threat Management Center
- ▶ Provides security training in Kabul, Afghanistan to Afghani judges, prosecutors and counternarcotics investigators
- ▶ Protects the Director of the Office of National Drug Control Policy in Washington, D.C., and when he travels
- ▶ Protects the Deputy Attorney General in Washington, D.C., and when he travels
- ▶ Protects the Supreme Court Justices when outside Washington, D.C.
- ▶ Coordinates security for judicial conferences throughout the United States
- ▶ Provides protective details for foreign officials during the United Nations General Assembly Sessions

Asset Seizure and Forfeiture

- ▶ Currently managing approximately 16,000 assets with a value of more than \$1.66 billion
- ▶ Real property represents 9.5 percent of total value
- ▶ Cash and financial instruments represent 75 percent of total value
- ▶ Vehicles comprise 28 percent of inventory items
- ▶ Approximately \$4.6 billion shared with state/local agencies since FY1985
- ▶ FY 2007 equitable sharing payments were approximately \$401 million

Prisoner Services

- ▶ Prisoners in daily custody: over 55,000
- ▶ Prisoners received yearly: 198,000
- ▶ Prisoners produced yearly: more than 863,000

Intergovernmental Agreements

- ▶ Intergovernmental Agreement jails: 1,800

Special Operations Group

- ▶ Specially trained tactical unit created in 1971
- ▶ Responds to emergencies anywhere in the United States or its territories
- ▶ Provides tactical support to district offices or as ordered by the U.S. Attorney General
- ▶ Headquartered at Camp Beauregard, a Louisiana National Guard installation

Witness Security Program

- ▶ Witnesses: More than 8,000
- ▶ Participants: More than 17,500 (witnesses and family members)

Budget (FY2008)

- ▶ Salaries and expenses appropriation: \$864,219,000
