Subject: Suspension of Fire Wood Cutting.

To: All Plumas Employees

It is my decision to implement Fire Restriction Order No. 14-08. This order supersedes Order No. 13-08. Due to the high fire danger, it is necessary to suspend wood cutting on the Plumas National Forest.

These restrictions are being implemented due to the current "very dry" forest fuels conditions and the current and forecasted weather that indicate hot and dry conditions will continue the remainder of the summer months into the fall. The potential for a new fire start to exhibit extreme fire behavior is high.

Energy Release Components are at record levels and 100 hour and 1,000 hour fuels are at critical levels producing very high and extreme fire danger. Analyses of current fuel conditions and weather observations, as compared to historic data have shown that the current conditions are following historic "worst case" wildfire scenarios.

This action is categorically excluded from documentation in an environmental impact statement or an environmental assessment because the project is within Category #1 of Section 31.12, Forest Service Handbook 1909.15, which includes Orders issued pursuant to 36 CFR Part 261. This regulation allows implementation of prohibitions or closures for short term resource protection or to protect public health and safety.

Order No. 14-08 Plumas National Forest Fire Restrictions

Pursuant to 36 CFR 261.50(a) and (b), and because of the high fire danger, the following acts are prohibited within the Plumas National Forest. This Order is effective from August 30, 2008, through the declared end of the 2008 fire season.

- 1. Building, maintaining, attending or using a fire, campfire, or stove fire, except in the designated recreation sites listed in Exhibit A. 36 CFR 261.52(a).
- 2. Smoking, except within an enclosed vehicle or building, within the designated recreation sites listed in Exhibit A, or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable material. 36 CFR 261.52(d).
- 3. Welding, or operating an acetylene or other torch with an open flame. 36 CFR 261.52(i).
- 4. Using an explosive. 36 CFR 261.52(b).
- 5. Operating an internal combustion engine, except for a motor vehicle, outside of the designated recreation sites listed in Exhibit A. 36 CFR 261.52(h).
- Possessing or using a motor vehicle off National Forest System roads, National Forest System trails, or outside of the designated recreation sites listed in Exhibit A. For the purposes of this prohibition, a wheelchair is not considered to be a motor vehicle. 36 CFR 261.56.

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order.

- 1. Persons with a permit from the Forest Service specifically authorizing the otherwise prohibited act or omission. Persons with a valid California Campfire Permit or a valid Forest Service fuel wood permit are not exempt from the prohibitions listed above. However, persons with a valid California Campfire Permit may use a portable stove or lantern using gas, jellied petroleum, or pressurized liquid fuel.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3. Persons may use suction dredges on water if authorized by a permit issued by the State of California.
- 4. Persons with a Special Use Permit from the Forest Service for a recreation residence on the Plumas National Forest are exempt from prohibitions No. 1, 2, 5 and 6 while they are at their recreation residence.

These prohibitions are in addition to the general prohibitions found in 36 CFR Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 USC 551 and 18 USC 3559, 3571, and 3581.
