Additional information on some of the individual trails listed here is available and so noted. That information contains a brief summary of the hike and detailed driving instructions to the trail head.

Bald Mountain / PCT Tie - Elev. 5080 - 6255

The trailhead is located at Horse Camp / Little Grass Valley Reservoir approximately 5 miles north of the town of La Porte.

Location - SW1/4Sec22 T22N R9E MDBM Trail Length - 2.3 miles one way Difficulty - Moderate

Big Bald Rock - Elev. 3100 - 3200

The trailhead is located at Big Bald Rock Day Use Area approximately 27 miles NE of Oroville near the town of Berry Creek.

Location - SE1/4Sec30 T21N R6E MDBM

Trail Length - .5 mile one way

Difficulty - Easy

Butte Bar / PCT Tie - Elev. 3800 - 2800

The trailhead is located at the end of a very brushy spur road approximately 20 miles NNW of the town of La Porte.

Dome - Elev. 2800 - 880

The trailhead is located approximately 29 NE of Oroville near the town of Berry Creek.
Location - SE1/4Sec28 T21N R6E MDBM
Trail Length - 2.5 mile one way
Difficulty - Moderately Difficult
Scenic hike skirting Bald Rock Dome to trails endon the Middle Fork of the Feather River.

Feather Falls NRT - Elev. 2400 - 1829

The trailhead is located approximately 24 NE of Oroville near the town of Feather Falls.
Location - NE1/4Sec11 T20N R6E MDBM
Trail Length - 9 mile loop
Difficulty - Moderate
Scenic hike to breathtaking overlook of Feather
Falls the 6th highest falls in the continental United States

Graves Cabin - Elev. 2100

This trailhead begins at the end of the Hanson Bar trail. It parallels the Middle Fork of the Feather River 2 miles upstream to the Graves cabin site and continues on 1 mile to the Kennedy cabin site.

Location - NW1/4Sec28 T22N R7E MDBM Trail Length - 3 miles one way Difficulty - Moderate Good campsites along the river.

Hanson's Bar - Elev. 4200 - 2100

This trailhead is located approximately 25 miles northeast of the town of Feather Falls. Vehicles should park in the wide flat area where the road narrows.

Location - SE1/4Sec32 T22N R7E MDBM Trail Length - 3 miles one way Difficulty - Difficult Good campsites at trails end. Fishing, Historic, Site seeing.

Sky High - Elev. 3500 - 2400

This trailhead is located approximately 6.7 miles northeast of Brush Creek Work Center or 31 miles northeast of the town of Oroville. .

Location - Nw1/4Sec26 T22N R6E MDBM Trail Length -1.5 miles one way

Difficulty - Moderate

Hartman Bar National Recreation Trail

This trail has two entry points that descend down both sides of the Middle Fork of the Feather River drainage to a suspension bridge that crosses the river. The nations record ponderosa pine tree is adjacent to this trail on the north rim. Dan Beebe Campground (undeveloped) is located on the south side of the river. There is a horse corral at each trailhead. This trail is not recommended for novice horse riders.

Hartman Bar North - Elev. 5100 - 2300

This trailhead is located approximately 54 miles northeast of the town of Oroville.

Location - NE1/4Sec3 T22N R7E MDBM Trail Length -4.4 miles one way Difficulty - Difficult

Hartman Bar NRT South - Elev. 4833 - 2300

This trailhead is located approximately 31 miles northeast of the town of Feather Falls.

Location - NE1/4Sec23 T22N R7E MDBM Trail Length -3.75 miles one way Difficulty - Difficult

Mountain House - Elev. 3500 - 1500

This trailhead is located approximately 2.5 miles northeast of Brush Creek Work Center or 27 miles northeast of the town of Oroville.

Location - NE1/4Sec4 T21N R6E MDBM Trail Length -1.9 miles one way Difficulty - Moderate

Wildcat Creek - Elev. 4760 - 2650

This trailhead is located approximately 18 miles north of Brush Creek Work Center or 31 miles north of the town of Oroville.

Location - CenterSec19 T23N R6E MDBM Trail Length -4 miles one way Difficulty - Moderate

The trail provides fishing access to Wildcat and Grizzly Creeks. Large pools at trails end at Grizzly Creek. View of Letter Box Falls from midpoint of trail.

Little North Fork - Elev. 4100

This trailhead is located approximately 15 miles northeast of Brush Creek Work Center or 40 miles northeast of the town of Oroville. The trailhead is on the upper side of the road across the bridge from Little North Fork Campground.

Location - SW1/4Sec1 T22N R6E MDBM Trail Length - 3 miles one way Difficulty - Easy first 2 miles

Trail follows the Little North Fork River north towards the historic Robinson Mine but the trail no longer actually reaches Robinson Mine. The first 2 miles of the trail are relatively level but the last mile rises rapidly This trail is not recommended for horses.

Table Rock - Elev. 6100 - 6908

This trailhead is located approximately 11 miles west of the town of La Porte.

Location - NE1/4Sec8 T21N R10E MDBM Trail Length -1 mile one way Difficulty - Moderate

The trail will take you to the top of Table Rock where you will have an outstanding view of the surrounding area.

Lakeshore - Elev. 5100

This trail is located approximately 5 miles north of the town of La Porte at Little Grass Valley Reservoir. The trail has access points near every campground around the lake. Equestrians can enjoy the section of the trail from Horse Camp to Black Rock Creek.

Location - Sec28-33 T22N R9E MDBM Trail Length -13.5 mile loop Difficulty - Easy

Pacific Crest Trail (P.C.T.)

For management purposes the P.C.T. is split into four segments on the Feather River Ranger District. The segments are listed in a north to south direction. Total distance of P.C.T. on Feather River Ranger District is approximately 32 miles.

P.C.T. Fowler Peak Segment

Middle Fork of the Feather River to Black Rock Creek

Location - T22N R9E Sec17 MDBM

The trail crosses the Middle Fork of the Feather River by way of a bridge completed in 1980. It parallels Onion Creek for a short distance before starting the long climb out of the canyon. The trail climbs steadily, switchbacking occasionally, and continues to climb after crossing a ridge and going through an extensive stand of canyon live oak.

2.0 miles from the Middle Fork of the Feather River the Dogwood Creek Road is crossed. The trail continues to climb with frequent views of the Dogwood Creek Road and visual evidence of logging. Several abandoned logging spur roads are crossed. After 3.2 miles, the two lane dirt Sawmill Tom Creek Road is crossed.

On the next 2.2 miles the trail continues to climb following skid trails and abandoned spur roads with evidence of logging in view.

Finally, the trail stops climbing and meanders around the northeast side of Fowler Peak and then descends to the Black Rock Creek Road.

P.C.T. Chimney Rock Segment

Black Rock Road to Quincy-La Porte Road Location - T22N R9E Sec15 MDBM

The trail follows an old four wheel drive road, staying on a ridge top the entire 7.3 miles of this segment. The four wheel drive road is posted "Closed". Roads are crossed at several sections. Vegetation consists of red fir with patches of manzanita. Views to the east and north are spectacular with some distant hydraulic mining scars visible.

P.C.T. Pilot Peak Segment

Quincy-La Porte Road to Johnsville-Gibsonville Road

Location - T22N R10E Sec9 MDBM

This section is 8 miles long. The trail climbs to Bunker Hill Ridge and then follows the ridge. Vegetation alternates between red fir stands and open rocky ridges with spectacular views. After crossing several roads, the trail leaves Bunker Hill Ridge with a slight descent skirting the northeast side of Mt. Etna (T22N R10E Sec26) in the vicinity of an old trail and mine. The trail utilizes and old ditch for several hundred yards before crossing a manzanita field and descending

P.C.T. Gibralter Segment

Johnsville-Gibsonville Road to the A Tree Location - T21N R11E Sec5 MDBM

This segment follows Nelson Creek across McCrae Ridge to the A Tree (T21N R11E Sec4), a distance of approximately 10 miles. Beautiful views on this whole segment.

Off Highway Vehicle Trails (OHV)
Other use such as biking, equestrian, hiking is also allowed. Poker Flat is not recommended for horses.

Cleghorn Bar 4x4 - Elev. 5000 - 3874

This trailhead is located approximately 22 miles north of the town of La Porte on the Sawmill Tom Road off of the Quincy-La Porte road.

Location - Sec31 T23N R9E MDBM

Trail Length -1.5 miles one way

Difficulty - Moderate

This moderately difficult 4x4 trail leads to

Cleghorn Bar Campground on the Middle Fork of

Poker Flat 4x4 - Elev. 5674 - 4754

This trailhead is located approximately 13 miles west of the town of La Porte.

Location - Sec10 T21N R10E MDBM

Trail Length -4 miles one way

Difficulty - Moderate

the Feather River.

This moderately difficult 4x4 trail leads from the Howland Flat / Mt. Filmore area, into the historic townsite of Poker Flat, along Canyon Creek.. There are still standing buildings in this historic townsite. The last two miles are high clearance 4x4 vehicles only.

Stag Point 4x4 - Elev. 5600 - 2788

This trailhead is located approximately 20 miles northwest of the town of La Porte.

Location - Sec10 T22N R8E MDBM

Trail Length -2.5 miles one way

Difficulty - Moderate

This moderately difficult 4x4 trail ends near the Middle Fork of the Feather River. The trail is narrow, steep, rough, and rocky with many sharp turns. Campsites at trail's end.


Little Grass Valley Accessible Fishing Trail

This cement trail has a gentle slope that drops down to the normal low water level of Little Grass Valley Reservoir. Several pull out parking stations were constructed at various elevations to allow fishing access as the lake raises or lowers. An accessible rest room is available at the top of the trail near the parking area.

LGV Accessible Fishing Trail - Elev. 5100

This trail is located approximately 5 miles north of the town of La Porte at Little Grass Valley Reservoir Dam.

Location - NE1/4Sec30 T22N R9E MDBM Trail Length - 800 feet Difficulty - Easy
