## **CDC Environmental Public Health Leadership Institute Projects**

The Centers for Disease Control and Prevention (CDC) Environmental Public Health Leadership Institute (EPHLI) is a 1-year program of seminars and workshops, special projects, and individual study. Each year, up to 30 practicing environmental public health professionals are admitted to the program. Since 2005, 113 fellows have graduated from the institute.
