

Wiregrass Outpatient Clinic Opens on Ft. Rucker

Veterans in Alabama's Southeastern, "Wiregrass" Region saw their medical support double with the recent opening of Central Alabama Veteran's Health Care System's (CAVHCS) Wiregrass Outpatient Clinic, located in Lyster Army Health Clinic, Fort Rucker, Ala., and also learned that the expansion of services in their area will continue.

"Last August we promised veterans that we would get as many of them off the road to Montgomery and Tuskegee as possible by expanding services right here in the Wiregrass Region," said Ms. Shirley Bealer, CAVHCS Acting Director. "Today we're delivering on that promise. In fact, we're committed to even further expansion, because we've also received approval for a \$2.9 million Joint Incentive Fund (JIF) project to renovate

additional spaces here in the Lyster Army Health Clinic."

The Joint Incentive Fund program has been an effective means of expediting CAVHCS' responsiveness to

the Wiregrass Region veteran community's expanding needs. "The Wiregrass Region is growing and our expansion efforts are designed to keep up with the veteran population in the entire region," said Dr. Robert Ratliff, Interim Director, Birmingham VA Medical Center - who is expected to return to his duties as CAVHCS Director following the ongoing process to hire a new Birmingham Director. "Our approach has been to expand our existing sharing agreement, which has been working very well, and access JIF funding. Together, we've been able to shorten what is usually at least a 24 to 36 month process."

"The 2003 Defense Authorization Act required that DoD

Celebrating History

Tuskegee Looks Back on 85 Years of Service

Central Alabama Veterans Health Care System (CAVHCS) recently celebrated 85 years of service to our nation's heroes at Tuskegee VA Medical Center (VAMC) in a ceremony that featured choral performances, fellowship with community leadership and the special recognition of Tuskegee's rich heritage.

"Today we celebrate 85 years of service," said CAVHCS Acting Director Shirley Bealer. "It's almost impossible to fathom the lives involved during that timeframe. From veterans and providers to support staff and family members, Tuskegee Veterans Medical Center has directly affected literally tens of thousands of lives."

Tuskegee VA Hospital's history began following World War I, when the Treasury Department Hospitalization Committee found that it was almost impossible to secure proper treatment for Negro soldiers in mixed hospitals for war veterans in the South.

Congress authorized the U.S. Treasury to build a hospital solely for the care of more than 300,000 black

veterans in the South. The hospital, which was constructed at a cost of \$2,500,000, featured 27 permanent buildings on a total of 464 acres of land adjoining the Tuskegee Normal and Industrial Institute campus.

The dedication ceremony of the Tuskegee VA Hospital, which was then known as the Hospital for Sick and Injured Colored World War Veterans occurred on February 12, 1923. The institution was passed, in authority, from the U.S. Treasury to the U.S. Veterans Bureau (which later became the Veterans Administration on July 21, 1930).

"Despite it's origin in a turbulent, segregated South – Tuskegee has grown with our nation," said Bealer. "Together, we have evolved to provide both opportunity and quality care to our nation's heroes regardless of race, creed, sex or socioeconomic status."

The 2008 ceremony featured a new award presented in recognition Dr. Toussaint T. Tildon, one of the first six African

April is Occupational Therapy Month

Each year in April, occupational therapists, occupational therapy assistants, and students in practice, education, research, and science host a month long celebration showcasing the importance of Occupational Therapy. It's the time of year when everyone in the profession goes out of their way to tell the world about what we do.

The person needing occupational therapy could be your father or mother facing changes because of aging. It could be your child, frustrated with being unable to do the seemingly simple things the other children at school can do. It could be you or your spouse coping with illness or the results of an accident. It could be anyone who, for whatever reason, can't do the things in life they want or need to do.

Occupational therapy focuses on enabling people to do the activities of daily life. The very word "occupation" – means an activity which "occupies" our time. A child in CAVHCS Salute - April 2008 Edition

grade school has the occupation of learning. An adult may need to learn how to write after a traumatic injury. A senior may want to continue driving safely in order to stay active in their community. All of these things are occupations and participating in them is vital to maintaining overall health and wellness.

Occupational therapy is skilled therapy based on performing the meaningful activities of daily life (self-care skills, education, work, or social interaction), dedicated to the improvement and maximization of function, performance and independence, despite impairments or limitations in physical or mental functioning. Occupational therapy is for individuals of all ages – to prevent injury, restore function and reduce disability to help them perform daily tasks at home and at school, at work and at play.

and VA establish a Joint Incentives Program, which in turn created a DoD-VA Health Care Sharing Incentive Fund," explained Col. Michael S. Kaminski, Commander, U.S. Army Aeromedical Center, Fort Rucker. "The intent of the program was to identify, fund and evaluate creative local, regional and national sharing incentives. The additional \$2.9 million renovation project will result in expanded services to active duty soldiers as well as our veterans."

New Wiregrass Region veteran enrollees will be directed to enroll at the new Wiregrass Outpatient Clinic aboard Fort Rucker. Current enrollees from throughout the entire region will also have an opportunity to enroll in the new clinic as well starting Monday. All they have to do is visit the new clinic and fill out an available form to transfer enrollment.

One element of the CAVHCS service expansion that is of particular importance to veterans from the southern part of the Wiregrass Region's Dothan area is the opening of a

American doctors to begin treating veterans in Tuskegee. Dr. Tildon arrived in Tuskegee after graduating from Harvard with a Medical Degree and started his career as a young doctor working in psychiatry. Thirty four years of dedicated service later, Dr. Tildon retired after serving for nine years as Tuskegee's Director.

"In 1923 young African American health care professionals were drawn to Tuskegee," said Bealer. "They knew the nation would take stock in their ability and they knew they would not only be able to provide care for black veterans, but they would also serve as beacons for other young African Americans. Their commitment and professionalism would be scrutinized, measured and compared to the highest standards."

First to receive The Dr. Toussaint T. Tildon Memorial Award for Outstanding Service was Air Force Master Sgt. (Ret.) Leon Crayton. "On behalf of the Tuskegee Airmen, Tuskegee Chapter I accept this presentation," said Crayton. "Time is a very important factor. It is written in the scripture, that there is a time for everything. So, if I were to leave you with a thought it would be this. When you change the way you look at things, the things you look at change. So God bless America. God bless Tuskegee and God Bless this VA institution."

According to the citation on the Tildon Memorial Award, "Recipients of this award are recognized for sharing Dr. Tildon's sense of purpose, resolve and professionalism. It is intended that in doing so, bestowing this award will not only serve as a tangible connection to a proud heritage, but CAVHCS Salute - April 2008 Edition

new contract to operate the existing Community Based Clinic in Dothan to prospective contract providers. "One of the three primary promises we make to all veterans is to expand while maintaining services," explained Bealer. "Today's opening, while simultaneously maintaining services in Dothan, allows us to deliver on that promise."

"We've been able to be responsive to Wiregrass veterans," added Ratliff, who spoke with hundreds of veterans in a Town Hall meeting in the Dothan Opera House last March. "Today's grand opening, as well as the upcoming continued expansion, is a direct result of a concerted effort to continually identify and resolve veteran needs."

will also serve to point the way as we move forward. Dr. Tildon's devotion to duty, community and compassionate treatment of the human spirit serves to inspire us today as it most assuredly did when he served."

In keeping with the design to point toward a bright future, next to receive the Tildon Memorial Award were the CAVHCS 2007 Employees of the Year, Mrs. Donzella Bozeman and Mr. Billy Cook. "I was almost brought to tears," said Cook. "The ceremony itself was wonderful, but when they gave me this award...it was touching. To serve for 34 years here at Tuskegee – to do anything for that long - Dr. Tildon must have loved what he was doing. I think that's something we have in common."

For one attendee the ceremony was equally moving. "I thought the ceremony was just beautiful, but to me it was so special, because my father was Toussaint T. Tildon," said Elizabeth Tildon Wood. "For him to be honored like this today was just so moving."

The presentation of the inaugural Tildon Memorial Award was a surprise to Dr. Tildon's third child and served to culminate an emotional morning. "Nobody told me, but I was just so happy," said Wood. "I didn't have any idea. I walked in to the auditorium and saw a picture of daddy at his desk with some other gentlemen. I haven't looked at the program yet. I just knew I'd cry if I read the program. I'm waiting until I get home."

"For the past eight decades we have been woven into the very fabric of the Tuskegee and Central Alabama communities," said Bealer. "Today – as we celebrate a rich heritage of service, we can also look forward with confidence that our future is bright. That future is not only ensured by our staff's commitment to excellence, but also by our established regional centers of excellence in Geriatric, long-term care, Rehabilitation and Mental Health."
