SUBJ: Electronic Access to Specific Air Traffic Organization (ATO) Directives within Federal Aviation Administration Headquarters

- **1. Purpose of This Notice**. This notice explains how FAA headquarters offices will access specific ATO directives and publications electronically.
- **2. Audience**. This notice applies to all offices within Washington headquarters.
- **3.** Where Can I Find This Notice? The notice is available on the MYFAA employee Web site at https://employees.faa.gov/tools_resources/orders_notices/ and on the air traffic publications Web site at http://www.faa.gov/airports_airtraffic/air_traffic/publications.
- **4. Action.** FAA headquarters personnel will view, download, and subscribe to receive electronic mail notification when changes occur to the specific ATO manuals, publications, orders, and notices at http://www.faa.gov/ATPUBS (Internet) or http://www.faa.gov/airports_airtraffic/air_traffic/publications (Intranet).
- **5. Scope**. This notice applies only to the ATO manuals, publications, orders, and notices as identified in appendix A of this notice.
- **6. Distribution**. This notice is distributed to all offices within Washington headquarters.
- **7. Background**. Hardcopy dissemination of ATO directives has been the primary means of notifying FAA employees about National Airspace System changes and related operational activities. However, ATO manuals, publications, orders, and notices have been available online through the Agency's Web site (www.faa.gov) for several years. Electronic access has many benefits, including unlimited search capability, enhanced mobility, customized downloading, reduced printing and shipping costs, and the preservation of our natural resources. For these reasons, hardcopy dissemination of the documents specified in appendix A will be discontinued within headquarters.
