Patient Movement Items




- Medical equipment and supplies required to support the patient during evacuation
- The purpose of the PMI system is to support patients in-transit, to exchange in-kind PMIs without degrading medical capabilities, and to provide prompt recycling of PMIs
- The handling and return of equipment to the originating theater through the evacuation system is the responsibility of the logistics function
- The originating Medical Treatment Facility is responsible for notifying the Patient Movement Requirements Center if the patient needs any special medical equipment for transport
