FOREST SUPERVISOR'S ORDER

Pursuant to Title 36 Code of Federal Regulations 261.50(b), the following acts are prohibited on the following National Forest System roads on the Lolo National Forest. These restrictions are in addition to those enumerated in Subpart A, Part 261, Title 36, Code of Federal Regulations, and become effective upon signing and will remain in effect until July 15, 2008.

36 CFR 261.54 - National Forest System roads

The following is prohibited:

Being on the roads (see attached list) with a motorized vehicle when gates are closed or signs are posted (36 CFR 261.54(a)). The purpose of the closures is to prevent damage to soft roadbeds. Restrictions will be removed or moved up the road as conditions improve.

Traffic on these roads is subject to the traffic laws of the State of Montana, except to the extent the above prohibited acts are in conflict therewith.

Exemptions:

Pursuant to Title 36 CFR 261.50(e), the following persons are exempt from this restriction:

- 1. Persons with a permit issued by a forest officer specifically authorizing the otherwise prohibited act or omission.
- 2. Any Federal, State or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

Penalty:

Violation of these prohibitions is punishable by a fine of not more than \$5000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC 551 and 18 USC 3559 and 3571).
