Successful applicants will be notified by telephone no later than March 13th, 2009. Only one lottery application will be accepted per person. You must be at least 18 years old to apply.

ALLOCATION OF RENTAL RESERVATIONS - DRAWING

A random drawing will be made in early March to determine the identity of successful applicants. Once the drawing is complete, lottery winners will be notified. Lottery winners will then have until March 31st to pay. Any unclaimed dates will become available on a first come, first served basis starting April 1st, 2009.

OTHER IMPORTANT INFORMATION ABOUT THE MORGAN-CASE HOMESTEAD

Payments: Successful applicants will be notified by March 13th, 2009. All payments must be received by March 31st, 2009. If payment is not received by this time your reservation will automatically be cancelled and the dates will be made available for call-in reservations starting April 1st, 2009. We accept cash, checks or credit cards.

Transfers: Reservations may be transferred to another party if the original holder calls the Missoula Ranger District and provides the name and telephone number of the person to which the reservation is to be transferred. A new rental agreement will need to be completed for the new holder prior to the reservation date.

Refunds: Permits are non-refundable. If the Morgan-Case Homestead site is closed due to wildfire danger during your scheduled stay, we will be unable to issue you a refund but will be able to credit you the same dates for the following summer.

Cancellations: All Morgan-Case lottery winners must make cancellations 30 days prior to their reservation. If your cancellation meets the 30 day requirement, we will reschedule your visit if dates are available. Reservations will not be rescheduled due to weather or road conditions.

Management Activities: A Forest Service employee may stop by (between the hours of 10 am and 6 pm) to perform routine maintenance on the grounds and in the cabin.

At anytime during your visit to the Morgan-Case you may encounter fire fighting personnel and equipment. Visitors will need to consider that there is an ongoing big game winter range improvement project that includes prescribed fire in much of the Rock Creek drainage. These management activities may lead to smoky conditions and the possibility of fire fighting personnel and equipment, including helicopters, in close proximity to the Morgan-Case Homestead.

Groups wishing to pool applications: If you are part of a group (max of 5 persons per party) you may pool your applications to increase your odds of a successful drawing. In the spaces on the following page, please provide the names of the other members of your group. If one group member draws dates, all other applications within the group will be pulled from the lottery pool.
