Estimated publication date is December 15, 2007.

- HWVP's goals are to:
 - Provide outreach to the community to identify female veterans who are either literally homeless or at risk of becoming homeless.
 - Provide case management for their medical or psychiatric needs, as well as provide assistance with navigating VA and social welfare systems.
 - Provide residential treatment in partnership with non-profit programs in the community.
- Discussed socio-demographic characteristics within these Special Programs:
 - Median age: 50 years.
 - Race: more than 53 percent are Black, not Hispanic
 - Marital status: nearly 60 percent previously married
