Dear Interested Party,

The Mt. Hood National Forest (the Forest) has identified you as an individual, agency, or organization that has shown interest in the planning process for the Road Decommissioning for Aquatic Restoration Project. The Finding of No Significant Impact (FONSI) and Decision Notice for this project are now complete. I have decided to implement Alternative 3, with some modifications, which will result in decommissioning about 76 miles of unneeded roads. I selected this alternative because I believe it best meets the need to restore impaired hydrologic function on the Forest, while also minimizing the impacts to recreation access.

The Decision Notice was signed by Forest Supervisor Gary Larsen on December 19, 2008. It is available on the Mt. This decision is subject to appeal pursuant to Forest Service regulations at 36 CFR 215. Any individual or organization that submitted comments during the comment period may appeal. Any appeal of this decision must be in writing and fully consistent with the content requirements described in 36 CFR 215.14. The Appeal Deciding Officer is the Regional Forester. E-mails submitted to email addresses other than the one listed above, or in formats other than those listed or containing viruses, will be rejected. It is the responsibility of the appellant to confirm receipt of objections submitted by electronic mail.

The appeal, including attachments, must be postmarked or received by the Appeal Deciding Officer within 45 days of the date legal notice of this decision was published in the Oregonian.
