Tier labels may be copied from one tier type to another tier type. Tier label copying is designed as a tier-by-tier copy function (i.e., Tier 1 Pre-ICL copies to Tier 1 Gap and/or Tier 1 Post-OOP; Tier 2 Pre-ICL copies to Tier 2 Gap and/or Tier 2 Post-OOP, etc.) and can only be done one tier at a time. Besides copying the tier label, the copy function also copies the three subsequent fields: 1) Select drug type(s) in this Tier; 2) Tier Includes (Enhanced Alternative only); and 3) Specialty Tier.
