# **PENDLETON INTERAGENCY COMMUNICATION CENTER**

## **2007 Center Manager Review**

This year's personnel at PICC included Center Manager Nancy Belt, Assistant Center Manager Becky Jones, and dispatchers Monica Jones and Rex Kamstra. Three of our summer helpers returned for their second season: Darcy Thompson (STEP), Natalie Hamby (ODF) and Caileen Jamieson (ODF). Our vacant STEP position was filled by Haylee Harper. All four came onboard in early June; Caileen and Haylee departed for school in August; Darcy left in September and started her new role as a mom; and Natalie stayed on until the end of fire season in October. PICC also had 36 additional helpers who assisted us throughout our summer season in Initial Attack, Extended Support and Expanded Dispatch. We kept Dispatch open 24 hours a day for 64 operational periods.

We started out 2007 with the Hanford Fire Department becoming the new dispatch host for the U.S. Fish & Wildlife Service Mid-Columbia Refuges, ending a decade-long run being hosted at PICC.

Our first statistical fire occurred in early April on the Walla Walla District with the last statistical fire happening in mid-November on the North Fork of the John Day District. Lightning starts kept us busy from mid-May through mid-September, with several multiple ignition days covering virtually all of our dispatch area. With the high intensity of the storms, the total number of lightning-caused fires was slightly above our historic average for the area. Acres burned, however, was well above average, as we supported multiple Type II fires (Monument Complex, Trout Meadows, Otter Creek and Ukiah Complex) as well as an above average number of Type III incidents.


Our first off-PICC dispatches took place in January supporting hurricane-related timber stand cleanup in Arkansas and continued through late November supporting wildfires in California. On-PICC dispatches accounted for almost 8400 person days, nearly 3200 days more than last season, a figure even more amazing considering agency crews and engines have been separated out of the count this year to their own impressive totals.


**Oregon Dept. of Forestry – Pendleton Unit  
Fire Management Report - 2007**

**Year in Review**


The 2007 fire season provided the Pendleton Unit of the Oregon Dept. of Forestry with a very active July and August. Extremely dry fuels, record setting ERC's, and intense periods of dry lightning set the stage for a potentially explosive situation. Fortunately, through a combination of strong initial attack, close coordination with cooperators, and a bit of luck, all fires were quickly contained and held within their first burning period. Both the number of fires and the acres burned exceeded the 10 year average.



Once again, the majority of the statistical fires on the unit were caused by lightning. The total number of statistical fires on the unit was 41. Of those, 30 were found to be caused by lightning and 11 were of human related causes. The 10 year average for the unit is 25 statistical fires. Typically, about half of those would be caused by lightning. The number of human caused fires increased from 5 in 2006 to 11 in 2007.



It is in large part due to dedicated employees, safe and aggressive initial attack, and outstanding cooperation with our partners that the unit was able to keep the total number of state protected acres burned in 2007 to 5,383. This number exceeds the 10 year average of 1,387 acres. The vast majority of these acres involved fast moving fires in grazing lands rather than timber.



In total, the unit's fire protection resources responded to 76 fire incidents. Of those 41 were statistical fires, 21 were fires in which ODF assisted our cooperators and 14 were non-fire crew actions such as smoke chases or un-permitted burns.

As mentioned previously, the higher numbers of fires and burned acres were primarily due to very active lightning storms and fast moving fires in grass and light fuels. Weather patterns and burning conditions created record setting burning indices for much of the months of July and August. Following severe fire seasons in 2005 and 2006, and limited moisture recovery over the winter of 2006-2007, heavier fuels were left with very low moisture levels. A reasonably good green-up in late spring in the live perennial grasses and other light fuels moderated fire spread early in the summer, but heavier fuels showed fuel moisture content well below normal, igniting easily and showing high consumption levels. As late spring and early summer progressed, a very dry weather pattern caused the annual fine fuels to cure and ignite easily, creating a ready path for fire to travel to heavier, already dry fuels. New maximum ERC's were set on 17 days between June 26<sup>th</sup> and July 17<sup>th</sup> (20 day period.) Northeast Oregon District declared closed fire season on June 19<sup>th</sup>. Fire season lasted 121 days, ending on October 18<sup>th</sup>. NEO enacted a Regulated Closure on July 10<sup>th</sup>. On October 1<sup>st</sup>, the Regulated Closure was suspended, and on October 18<sup>th</sup>, both the Regulated Closure and Closed Fire season were terminated.

The Pendleton Unit, through aggressive initial attack, close coordination and help from our cooperators, was able to quickly contain all fires occurring on our protection. One set of fires, the Ukiah Complex, required the assistance of a fire team. This fire team worked jointly for both the Pendleton Unit of the ODF and the North Fork John Day District of the Umatilla NF. This was truly an interagency effort, with local crews and resources managing to get containment lines around almost 4,500 acres of both private lands fires and USFS fires within the first burning period. Only minor losses of acreage occurred during the next operational period, and the team was able to strengthen and hold established firelines, and begin mop up almost immediately.

Eight statistical fires exceeded 100 acres. The ERC's exceeded the 80 percentile level (the point where fires have a high potential to grow large quickly) from the first days of July through the middle of August. The Unit's ability to respond to these high potential incidents was greatly aided by appropriate use of District and State severity resources (dozers, helicopters, overhead, and engine crews) throughout the course of the summer.

#### Fires and Events of Significance

The Pendleton Unit dealt with numerous fires that presented high potential to become larger fires. The majority of these incidents came during occurrences of dry or nearly dry lightning storms throughout the months of July and August.

The first significant set of fires occurred early in July. On July 13<sup>th</sup>, a dry lightning storm ignited numerous fires in the Ukiah area. ODF and USFS fire crews responded to these incidents together, regardless of ownership. As a result, none of the fires escaped initial attack, although several required extended mop-

up afterwards. A few hours later, another storm passed over the northern portion of the unit, setting three fires in the Government Mountain area. Local RFD's, landowners, and resources from the La Grande and Wallowa Units were successful in catching these fires. Two of these fires exceeded 100 acres of mostly grass and brush type fuels.

Late at night on August 1<sup>st</sup>, the unit received notice of a large fire burning in the Government Mountain area. Crews responded and found approximately 100 acres of grass and heavy brush burning in a steep draw. The fire was contained by daylight, and controlled by evening. This obviously human caused fire was thoroughly investigated by both ODF and Oregon State Police Arson investigators, but no responsible party was identified.

Another late night fire was ignited on August 10 when the driver of a automobile transport truck either fell asleep or passed out and drove off of I-84 as he was pulling Emigrant Hill grade. The ensuing fire, while not large, destroyed all of the new vehicles he was transporting as well as the truck-trailer vehicle carrying them. The fire required significant coordination between ODF, Tribal Fire, ODOT, OSP, and the towing company to safely handle while also dealing with the traffic on the freeway.

On the 15<sup>th</sup> of August, the Ukiah area experienced another significant dry lightning event. This storm, though relatively compact and short-lived, was extremely active for a short period of time. By some accounts, approximately thirty fires were ignited in less than 30 minutes time from about the same number of down strikes. As the storm began, numerous agency resources as well as local cooperators were positioned in the storm's footprint area, ready to respond quickly. Never-the-less, many of these fires immediately exceeded 100 acres, and several grew together to form the Owens Butte fire which burned almost 3,800 acres total. Significantly, local fire resources were able to completely line all of the fires during that first burning period. All of these fires were combined into one "complex." The "Ukiah Complex" was originally handled by local agency managers and crews, but was turned over on the second day to the "ORCA" Fire Management team who happened to be in Ukiah working on a wilderness fire (Trout Meadows) for the N. Fork John Day RD. Rather than bringing in a different team, both agencies decided to utilize the ORCA team to help us through this situation. In addition, a state team from Maine was transitioning with the ORCA team to finish up work on the Trout Meadows fires. After a few days, the Maine team was able to take over for the ORCA team who needed to have a rest period. By working together to resolve this situation, greater efficiency and cost savings were realized by both agencies

The last of the dry lightning events of the season occurred on the 30<sup>th</sup> of August. An early morning storm came across the Ukiah area, igniting a number of fires on private and public lands. The largest of the fires on private land was the Snipe Hunter fire, which burned about 20 acres of timber-grazing lands. ODF and USFS fire managers once again coordinated closely in distributing resources between state and federal fires, minimizing the loss to both agencies.

e City of Pendleton. A 1500 acre, railroad caused fire burned into the west side of the City, threatening numerous houses, properties, and livestock. ODF engine crews played a significant role in helping to control this fire.

Pendleton Unit resources assisted other NEO Units and agencies on several fires, but in general were kept well occupied here at home this year. Mike Jones did go to Georgia in the spring as a Dozer Boss on the Big Turn-around Fire. Individually, the entire suppression force of the Unit was at one point or another assigned to incidents either in other portions of NEO or outside the district.

### Prevention

With funding assistance through a National Fire Plan Prevention Grant, the Unit continued to lead an effort to insert Fire Prevention ads in the East Oregonian, the Walla Walla Union Bulletin and the Confederated Journal (CUJ) throughout fire season. This year, the CUJ ads were funded directly by the Umatilla Agency BIA through a Prevention Grant. Forest Officers made numerous one-on-one contacts with the public through patrols and writing burning permits. Once again, Northeast Oregon District was able to utilize prevention money to send a fire prevention letter to all Northeast Oregon hunters who received a buck deer tag.

The “Northwest Passage Fire Prevention Cooperative” continued to work towards an interagency approach to fire prevention this summer. The group was successful in applying for grant “seed money” to help with this effort. The area served by this group compasses the Umatilla and Morrow County areas in Oregon and the Walla Walla County area in Washington. Work is continuing on potential projects for future years.

The unit was able to utilize prevention grant dollars to construct and erect nearly 30 new fire regulation level sign boards throughout the unit. These signs were placed in highly visible areas of high traffic or fire concern. These signboards incorporated a unique “fold-down” format that will replace several paper type “fire season” and “regulated closure” signs.

### Cooperative and Project Work

Funding through National Fire Plan grants has enabled the Unit to continue its effort to create defensible space and fire breaks to help minimize the exposure of private residences and private forestlands to catastrophic fires. Pendleton Unit personnel are working with forest homeowners within the Unit to conduct homesite assessments and to provide financial assistance to complete fuels reduction work within the immediate vicinity of a homesite. Assessments have been completed on about 1600 homes in the wildland urban interface. Fuels reduction work has been completed around approximately 131 homesites to date. These cost-share grants have also allowed the Unit to work with private forestland owners to reduce stand density and fuel loading on over 4180 acres in

the last four years. These programs have been well received and the results are very encouraging.

This year was the first full year of the implementation of the Oregon Forestland-Urban Interface Fire Protection Act of 1997 (Senate Bill 360 Process). The law requires property owners in identified wildland-urban interface areas to reduce excess vegetation which may fuel a fire, around structures and along driveways. In some cases, it may also be necessary to create fuel breaks along property lines and roadsides. Under the leadership of the Department of Forestry and through coordination with Umatilla County Commissioners, a committee was appointed to identify areas of forestland-urban interface and apply SB 360 fire risk classifications to those areas. Property owners affected by the requirements of SB 360 have two years after receiving their letter of notification (early 2007) to comply with the defensible space/fuel-reduction standards. Key areas identified in Umatilla County can be found near Mill Creek, Tollgate, Meacham and Ukiah. The program has been generally well received by landowners in the affected areas.

### Summary

The 2007 Fire Season began early, saw noteworthy activity during July and most of August, and continued with high fire danger through to mid October. Lightning contributed significantly to the higher number of fires in the Unit, but human caused incidents also were above average. Although the number of acres burned was higher than normal, most of those consumed acres were grass and brush rather than timber. Thanks to the efforts of the Unit's employees, our cooperators, and landowners, we were able to rise to the challenge posed by the fires that did occur, and successfully meet our landowners and the general public's expectations. In addition to actual fire suppression work, we made good progress in prevention, education, and hazard reduction efforts throughout the Unit. Once again, my thanks go out to all who contributed to the success of the Pendleton Unit this year.

## **HEPPNER RANGER DISTRICT**

### **Season Review**

#### **Suppression**

The Heppner Ranger District had an average season as far as number of starts, with a higher number of acres burned. Initial attack suppression resources handled 35 wildfire incidents on the District for a total of 19,947 acres. On July 12<sup>th</sup> and early the 13<sup>th</sup> we had a predominately dry storm move across the district resulting in multiple starts. Several of those starts grew into the Monument Complex which required the use of 2 Incident Management Teams, Blue Mountain and the Central Oregon Team. Crews assisted ODF with numerous fires as part of mutual aid agreement.

The district provided crew members for 5 Forest Agency Crews.

Provided support for Large Fire activity.

Assisted with the Tri-Forest Guard School by supplying a crew boss trainee.

Gary Popek flew approximately 95 hours of Aerial detection for the Forest.

Heppner Fire Management continues to be fully a District effort, as 34 out of 45 employees were red carded at the arduous level. Those few not red carded at the arduous level all function in support type roles locally, at the Forest level, and nationally.

Kristen Marshall was the Camp Coordinator for the Fire/Fuels Career Camp, held at Tupper on October 22-26. The Career Camp was held with 14 Senior's from local high schools being put through a variety of task's to

Madison Butte Look Out was staffed from mid July through the end of September. The lookout was staffed this year by Michael Duffy of Sentinel Mountain Lookouts LLC. This is the first year of a 3 year contract.

#### **Fuels Management**

The District had a slow year for burning. Accomplishments included: burning 233 acres of natural fuels and activity related fuels, 336 acres of wildlife habitat improvement, 64 acres of mechanical treatment.

Because of the Monument fire, three planning efforts were affected requiring changed condition reports from the fuels specialist.

Scott Wrynn completed BD appraisals for 3 timber sales.

A proposal was completed and accepted for Title 2 money to complete a hand piling contract for the Black Mtn. Hazardous fuels project.

## **Staffing**

We filled in behind the departure of Hank Falcon, with Brian Spradlin as the District Fuels Specialist.

We were asked to staff at MEL –10 again this season. We staffed 3 engines and a 5-person effective hand crew out of Tupper this year and a Patrol out of Heppner. We continue to be in flux with our permanent work force on the Suppression side; Andrew Fisher took a lateral position to McCall, Idaho and Britany Fink resigned her position. We filled one Module Leader with Derral Thomas, from the Wallowa Whitman NF, an Assistant with Jeromy Wilson from the Union IHC, And Scott McCreary from the Okanogan-Wenatchee NF. Jeromy detailed into the IA Crew Module leader position for the summer.

## **Prevention**

The prevention program on the Heppner Ranger District is in a never-ending process of redefinition. Cindi Doherty continues to be a big asset to the program by helping schedule Smokey Bear functions through out the year. This years prevention activities included:

- The continued maintenance prevention signs throughout the District.
- The inclusion of an engine and Smokey Bear in the St. Patrick's Day and Morrow County Fair parades.
- Made public contacts with forest visitors regarding fire danger.
- Crews spent time assisting with Tupper Outdoor School.

## **Project Work**

- Continued improvements to Tupper work center assisting in facilities.
- Continued fuels work around Tupper as part of Tupper fuels reduction project.
- Trail maintenance on appx 15 miles of trail
- Cut appx 1 mile of aspen fence right of way on 6 different locations
- Participated in the rouging of excess trees at the Mallory Seed Orchard
- Thinned and hand piled material around Mallory Seed Orchard for site protection
- Pruned residual trees at Black Mountain Unit 14 (Cutsforth Park) along Forest Boundary.
- Assisted w/burning on Walla Walla RD.

## **FRAZIER RAPPEL BASE**

### **Season Review**

#### **Overview**

2007 proved to be another productive and eventful season for the Frazier Rappel Program. The Tri-Forest area had a very busy fire season thus keeping us occupied for a large portion of the summer.

#### **Staffing**

Three of our five PSE's moved on to other programs this past spring. Norm Sealing, a squad leader, took a position with the Provo Rappel program in Utah. Jess Wright, a Senior Rappeller, took a position with the Logan Hotshots in Utah. Last but not least Jake Mason, a Senior Rappeller, moved to Idaho and got a Senior position with the Challis Rappel Crew.

We hired Joe Cochran as a Senior Rappeller in March and he later received the Lead Crew position in August. During the latter part of the season we were able to fill the remaining vacancies. Kane Lester filled the other Lead Crew position. Kane comes to us after several seasons with the Wenatchee Rappel Crew up in Northern Washington. Eben Babb received a Senior position. Eben has a good resume of experience over the last several seasons, including two years with the John Day Rappel crew and some great fuels management and hand crew time. Jason Gibbons accepted a Senior slot. Jason comes from the Central Oregon area and has a resume consisting of several years of hotshot time, smokejumping, and a season with the Sled Springs Rappel Crew. Chris Schram received the final Senior position. In February 2007, Chris completed his service time with the U.S Navy and after a season with the Sled Springs Rappel Crew has moved to Frazier. We are very excited about our newly acquired leadership and can't wait for the upcoming season.

#### **Suppression**

Operationally we kept quite busy on a local level. Our aircraft and crew didn't leave the Region at all this season except for a couple of boosts over in Idaho. We rappelled 26 fires, the most of any program in the region, helitacked 9 fires and van attacked 4 fires for a total of 39 initial attacks out of our own aircraft. These numbers don't reflect the fires that we staffed with other aircraft.

We hosted a Type-1 Helibase on the compound for over a month. Our crewmembers played an integral role in the daily operations of the Helibase that supported several project fires including the Ukiah Complex and Trout Meadows incidents.

The Siskiyou National Forest requested that we preposition our aircraft in Grants Pass on two separate occasions. We arrived right before a significant lightning event and were able to locate and rappel several fires. We promptly returned home to assist the Umatilla with the lightning bust that ended up producing the Monument Complex. The preposition system worked quite well for everyone as we received several boosts from other programs in the Region during critical times of our own.

## WALLA WALLA RANGER DISTRICT Season Review

### **Fire Suppression**

There were a total of 21 statistical Fires on the Walla Walla Ranger District this year. Lightning caused 18 of these fires and the other 3 were human caused. A total of 173.1 acres were burned on District. Cost for initial attack and suppression of all fires managed by Walla Walla Ranger District totaled \$578,100.

We had several major lightning storms this year causing a total of 18 fires and burning a total of 171.9 acres. Human caused fires were only a small factor this year with two fires burning 1.2 acres.

We sent a total of 41 people to various incidents and severity details off-District. These assignments included supporting nine Forest crews and also included prescribed fire support for Mississippi. We also filled numerous Overhead support requests with assignments in Montana, Nevada, Washington, Oregon and Alaska.

### **Personnel**

2007 brought a few changes in personnel. Bob Allbee detailed into the Operations AFMO position for a few months early this year. Rachael Berthiuame was detailed to the La Grande Hotshots for the season. She graduates from the Apprentice Academy in February, 2008. Justin Kropf retired from the Forest Service. Denise Spain graduated from her Master's Degree program and was hired by a school in Central Washington State. Sterling Horn has been accepted into the Apprentice Program for 2008. Kyle Melton was transferred to the Pike-San Isabel National Forest in Colorado where he will work in Timber Management.

Our thanks to Table Rock Lookout (Jim Lyon) and High Ridge Lookout (Leann Goldey) for their 29% of spotted fires. They also spotted a number of non-statistical fires in cooperation with NOIDC, the Wallowa-Whitman NF and Point Prominence. The big fire detection prize this year goes to our Aerial Reconnaissance, usually featuring Jeff Bloom, for their 33.3% (1/3) of our detected fires.

### **Prevention**

Fire Prevention resulted in only two human-caused fires on the Walla Walla Ranger District this year. Jimmye participated in an International Fire Prevention Education Team assignment to Jamaica for two weeks in May. He illustrated a brochure, activity sheets and a children's story book to help educate the children of Jamaica as well as a brochure with home protection tips plus a checklist for the adults. Smokey Bear appeared at many local schools and also in various parades around the District area, including the Pendleton Round-Up parade.

Jimmye assisted Heppner with a Fire/Fuels Career Camp at Tupper Guard Station on the Heppner Ranger District. The Camp was funded via a Regional grant and resulted in participants from the Boardman, Irrigon and Heppner High Schools and several new Student Employees for the summer of 2008. Jimmye also assisted with the Morrow County Children's fair and taught Fire Prevention and Fire's Role in the Ecosystem at the Hermiston School District's annual Outdoor School held at Umatilla Forks.

Jimmye also worked with the City of Walla Walla and Walla Walla County Emergency Services to put on two FIREWISE programs; for Walla Walla and also the town of Dixie. He worked with Emergency Services Manager Don Marlatt.

At the request of the Regional Office, Jimmye addressed the Cabin Owners Association of America in Portland, Oregon. He gave a presentation on the purpose and value of defensible space in cabin design.

Jimmye taught in two sessions of M-410 Facilitative Instructor and one session of P-310 Fire Prevention Education Team Member at Redmond Air Center.

He is president of the newly formed Northwest Passage Fire Prevention Co-Op including the Oregon Department of Forestry, the Pendleton Fire Department, the Hermiston Fire Department and Umatilla County.

### **Fuels**

We had good fuels accomplishment this year. Our efforts brought 1020 acres accomplished by burning including: 619 acres of natural fuels and 801 acres of activity fuels. Along with these totals we also had 1210 acres of mechanical treatment accomplished in Wildland Urban Interface.

### **Project Work**

Our Engine Crews and the Hand Crew worked at various tasks around the District. One significant project consisted of the Fire Crew assisting in the Timber Sale preparation for the Loon Timber sale. They assisted in taking out hazard trees in several campgrounds and cleared roads all across the District. They also did sign maintenance work for Fire Prevention at various times throughout the summer. Crews also did fuels work by piling and burning fuels all over the District. Both Spring and Fall burning projects were accomplished without a hitch. Crews completed their work this year without one lost-time injury.

The Walla Walla Ranger District also assisted the City of Walla Walla after the windstorm of January 2008 by sawing up some fallen trees in Ft. Walla Walla Park.

## **POMEROY RANGER DISTRICT**

### **Season Review**

Pomeroy RD was fortunate this year to evade a large fire after the School Fire in 2005 and Columbia Complex in 2006. Through several pulses of lightning ignitions, all starts on district were caught while small. Recognition must be given to the benefits of our cooperative relationship with the Washington State Department of Natural Resources. As we assisted the DNR in cooperative ground, they in turn reciprocated with some crew and helicopter help on federal ground. Pomeroy resources combined efforts with the DNR to organize and staff three type III initial attack scenarios: The Rockpile Creek Fire, the Cottonwood Fire, and a preposition effort for the last lightning bust in August.

Pomeroy Fire Management filled an Assistant Crew Leader position in September. Shay Logue came to us from the Turnbull Wildlife Refuge where he spent a lot of time doing prescribed fire. He has a quiet and calm approach to fire, so make him feel welcome as he settles into the routine of the forest.

The fall burning season had a long window that allowed us to make some good fuels accomplishment. Steve Carlson and Tara Hanger did a great job in coordinating the burning. They stuck to the task for many weeks, even through hunting season, when our crews would rather pack a gun than a drip torch.




