#### 5) Monitoring

**a. EOY (Effectiveness)** End of year four inch stubble was met in Unit 3. In Unit 1, end of year stubble height was not met at one location to standards for various reasons including: use by a transient and his stock, trailing by unathorized permittee, and because a fire camp was located on the site.

**b.** Long Term (Implementation) <u>Six Designated Monitoring Areas (Riparian) were re-read</u> using MIM protocol in 2007. All six sites show improvement from earlier measurement.

6) Miscellaneous: Allotment was impacted by two large wildland fire events, the Van Horn and Shower Bath Fire. Because of the Van Horn Fire the permittee's at one point had to remove all cattle off the forest to private ground, where they could if needed move cattle to a safe location. This removal lasted two weeks before they were allowed back onto the forest. Both the Shower Bath and Van Horn fire did burn some suitable acres and will need to be further reviewed to see if resource protection is warranted for the next grazing season.
