The boundaries of the regular blocks are 4,800 international meters on a side and contain 2,304 hectares. The regular boundaries are defined in terms of X and Y coordinates of the Universal Transverse Mercator Grid System based on the Geodetic Reference System (GRS) 1980 Ellipsoid.

Onshore planimetric base compilation for Puerto Rico and the U.S. VI is from NOS "T" sheets (1:10,000). British VI is from USGS Coastline Extractor, World Vector Shoreline (1:250,000).

The areas along the dashed Commonwealth Submerged Lands Boundary have not been determined. Areas and dimensions of the irregular blocks along the zone boundary are as indicated.

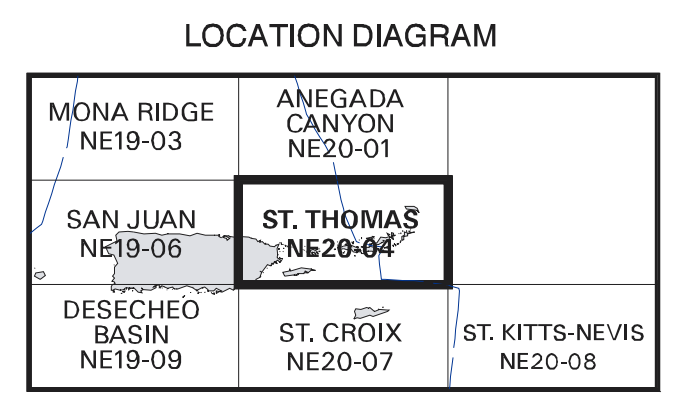
