SNOWMOBILE TRAVEL MANAGEMENT

Current Condition

The Beartooth Ranger District has limited opportunities for quality snowmobile recreation. This is due to limited access, the presence of steep and rugged geographical features and terrain, un-reliable and inconsistent winter snow pack and large areas of designated National Forest wilderness.

Most recreational snowmobile use on the Ranger District is concentrated on the Main and West Forks of Rock Creek along existing roads. The Picket Pin Road is fairly popular as well and affords access to the Gallatin National Forest. The Beartooth

Highway at the Quad Creek winter trailhead allows experienced snowmobile riders access to the Beartooth Plateau, Shoshone National Forest and Cooke City, Montana.

Desired Condition

Continue to allow snowmobile activities as in the past subject to existing closures and winter snow pack conditions. Increase the management of snowmobile use in areas where activities can potentially conflict with other resource values such as the Wild Horse Range or winter elk habitat areas.

Travel Management Strategy

Provide for managed snowmobile recreation opportunities where terrain and snow conditions permit.

Forest Management Direction

Forest Plan direction for snowmobile use is defined in only Management Area C which states, "Vehicles including snowmobiles may be restricted on big game winter range as needed to meet wildlife needs."
