


### **VICINITY MAP**



#### **PROHIBITIONS**

It is prohibited to possess or operate a motor vehicle on National Forest System lands on the Rocky Mountain Ranger District other than in accordance with these designations (36 CFR

Violations of 36 CFR 261.13 are subject to a fine of up to \$5,000 or imprisonment for up to 6 months or areas on National Forest System lands. both (18 U.S.C. 3571(e)). This prohibition applies regardless of the presence or absence of signs.

This map does not display nonmotorized uses, over-snow uses, or other facilities and attractions on the Rocky Mountain Ranger District. Obtain a forest visitor map for more complete information.

Designated roads, trails, and areas may also be subject to temporary, emergency closures, and restrictions. A national forest may issue an order to close a road, trail, or area on a temporary basis to protect the life, health, or safety of forest visitors or temporary and/or emergency closures are consistent with the Travel Management Rule (36 CFR 212.52(b); the vehicle in question. 36 CFR 261 subpart B).


The designation "road or trail open to all motor vehicles" does not supersede vehicle size or weight limits imposed through State traffic law.

#### Special Vehicle Definitions

ATV - Motorized trail vehicles less than or equal to 50" in width with three or more lowpressure tires, handle-bar steering and a seat designed to be straddled by the operator.

Motorcycle - Motorized trail vehicle with two wheels (one behind the other) with a seat designed to be straddled by the operator, 40-inches or less in width, capable of being operated on a singletrack trail with a maximum tread width of 18inches.

# **PURPOSE AND CONTENTS OF THIS**

This map dated 05/01/2008 shows the National Forest System roads, National Forest System trails, and the areas on National Forest System lands in the Rocky Mountain Ranger District Sun Canyon Area that are designated for motor vehicle use pursuant to 36 CFR 212.51. The map also contains a list of those designated roads, trails, and areas that enumerate the types of vehicles allowed on each route and in each area and any seasonal restrictions that apply on those routes and in

Designation of a road, trail, or area for motor vehicle use by a particular class of vehicle under 36 CFR 212.51 should not be interpreted as encouraging or inviting use, or to imply that the road, trail, or area is passable, actively maintained, or safe for travel. Motor vehicle designations include parking along designated routes and at facilities associated with designated routes when it is safe to do so and when not causing damage to National Forest System resources. Seasonal weather conditions and natural events may render designated roads and trails impassable for extended periods. Designated areas may contain dangerous or impassable terrain. Many designated roads and trails may be passable only by nigh-clearance vehicles or four-wheel drive vehicles. Maintenance of designated roads and trails will depend on available resources, and many may receive little maintenance.

This motor vehicle use map identifies those roads, trails, and areas designated for the motor vehicle use under 36 CFR 212.51 for the purpose of enforcing the prohibition at 36 CFR 261.13. This is a limited purpose. The other public roads are shown for information and navigation purposes only and are not subject to designation under the Forest Service travel management regulation.

#### **OPERATOR RESPONSIBILITIES**

Operating a motor vehicle on National Forest System roads, National Forest System trails, and in areas on National Forest System lands carries a greater responsibility than operating that vehicle in a city or other developed setting. Not only must the motor vehicle operators know and follow all applicable traffic laws, but visitors must comply with signs notifying them of such they need to show concern for the environment as well as 5270000 other forest users. The misuse of motor vehicles can lead to the temporary or permanent closure of any designated road, trail, or area. Operators of motor the natural or cultural resources in these areas. > Motor vehicle use, especially off-highway vehicle use, involves inherent risks that may cause property damage, serious injury, and possibly death to participants. ## **EXPLANATION OF LEGEND**

Roads Open to Highway Legal Vehicles Only:

These roads are open only to motor vehicles licenced under State other road or trail symbols, indicates that the road law for general operation on all public roads within the State.

Special Vehicle Designation:

This symbol indicates that the road or trail is open to classes of vehicles other than those listed above. Refer to the Seasonal and Special Designation Table for further instructions. Trails Open to Motorcycles Only:

These trails are open only to motorcycles. Sidecars are not permitted.

#### Seasonal Designation:

This symbol, used in conjunction with one of the or trail is open only during certain portions of the vear. Refer to Seasonal and Special Designation Table for further instructions.

Road Numbers Marked With

These roads are too short to be accurately seen on this map. Their seasons of open use are listed on the Seasonal and Special Vehicle Designation Table.
